We the undersigned qualified property tax pay-

McGowan, in my capacity as County Judge of Sabine County, Texas, do hereby order that an election be held on the 17th day of December A.D. 1910 at the Court House in Hemphill, Texas in said School District No. 1, of this County as established by order of the Commissioners Court of date the 15th day of May A.D. 1910 which is recorded in Book 9 on pages 302, 303 & 304 of the minutes of said Court to determine whether a majority of the legally qualified property taxpaying voters of that District desire the issuance of bonds on the faith and credit of said Common School District in the amount of \$150,000.00 the bonds to be of the denomination of \$100.00 each numbered consecutively from 1 to 150 both inclusive payable in 40 years from their date with option of redemption after ten years and bearing 5% interest per annum, payable annually April the 10th of each year, to provide funds to be expended in payments of accounts legally contracted in buying site and erecting brick school house and to determine whether the Commissioners Court of this County shall be authorized to levy, assess and collect annually while said bonds or any of them are outstanding, a tax upon all taxable property within said District sufficient to pay the current interest on said bonds and provide a sinking fund sufficient to pay the principal at maturity.

All persons who are legal qualified voters of this State and of this County and who are resident property taxpayers in said District shall be entitled to vote at said election.

The Sheriff of this County shall give notice of said election by posting three notices in the said District for three weeks before the election.
