 Court being duly opened by proclamation of the Sheriff the following proceedings among others were had to wit:

On this the 11th day of September A.D. 1911 came on to be heard the report of Jury of View appointed to lay out and survey a road beginning at Humphill and Godwin Ferry road where the same leaves the Sabintown road thence down the Godwin Ferry road about 250 yards thence in a northerly on a ridge route as nearly straight as practicable to the southwest corner of the J. H. Oliphint 50 acre tract on the 3^d Land League of land and the southeast corner of the W. A. Hogan 100 acre tract on said Land League thence north with the dividing line between the two above mentioned tracts of land to where said line crosses the Humphill and Sabintown road as it now runs and on Top of the hill north of the W. A. Hogan place.

It is ordered that the same be approved, that said road is hereby established, and that field notes of said survey and description of said road be recorded in the minutes of this court.

It appearing to the Court that no damage claims have been presented by the owners of said land.

It is therefore ordered that said new road be and is hereby classified as a road of the first class, that so much of said new road as lies within road precinct No. shall constitute a part of said precinct and that the overseer of road within said precinct cause said new road

to be opened and worked.

It is further ordered that the timber along said above mentioned road be reserved for the benefit of said land owners.

In the Honorable Commissioners Court of Sabine County,

The undersigned jurors, acting under the order of this court made on the 14th day of August, 1911, and after being duly sworn, did on the 8th day of September, 1911, proceed to lay out and survey a road, beginning at Hemphill and Lodwin Ferry Road where the same leaves the Lobinetown road, thence down the Lodwin Ferry road about 250 yards, thence in a northerly direction on a ridge route, as nearly straight as practicable to the southwest corner of the J. N. Oliphant 80 acre tract on the J. S. Lacy League of land and the southeast corner of the W. A. Hogan 100 acre tract on said Lacy League thence north with the dividing line between the two above mentioned tracts of land to where said line crosses the Hemphill and Lobinetown road as it now runs, and on top of the hill north of the W. A. Hogan place, and after having given notice in writing to W. H. Know one of the land owners, a verbal notice to Hamilton and H. E. Pratt & J. M. Minton, the other land owners through whose land said road runs.

W. H. Know appeared by his agent, W. S. Arthur, and assessed no damages, the other land owners AD, Hamilton, H. E. Pratt & J. M. Minton also assessed no damages.

The field notes of said survey and description of said are as set out above. All of which is respectfully submitted for the further orders of this court,

Barker, of Memphis Sabine County Texas, be and that he is hereby appointed Commissioner to sell and dispose of the real estate belonging to Sabine County, consisting of all of Block No. 13, Block No. 14, block no. 48, Lot no. 3 in Block no. 11, the West ~~part~~^{Block} No. 20, the South $\frac{1}{2}$ block no. 45, in the town of Memphis, according to the original map or plat of said town, and that he be authorized to advertise and offer for sale at public auction for cash to the highest bidder on any sheriff's sale day the above described property at the Court house door in the town of Memphis Sabine County, Texas, and that the said James W. Barker, be and is hereby authorized to make title to the purchasers thereof to any lot or lots sold as Commissioner of real estate of Sabine County.

It is ordered by the court that the Clerk issue to the members of the court their per diem for one day service.

It is ordered that the court stand adjourned until the next regular term.
