

Be it remembered that on this the 6th day of January A.D. 1918, the County Commissioners' Court of Sabine County, Texas, met in regular session at the court house in Hemphill, Sabine County, Texas, Present and presiding Hon. T.R. Smith, County Judge. L.A. Jordan Commissioner Precinct No. 1. W.J. McDaniel, Commissioner Precinct No. 2. S.H. Hall, Commissioner Precinct No. 3. M.E. Carter, Commissioner Precinct No. 4. R.J. Solly sheriff and W.R. Hyden Clerk.

Court being duly opened by proclamation of the sheriff the following proceedings among others were had, to-wit:

It is ordered by the commissioners' court that the assessment of Mrs. C. W. Epler Form "D" (unrendered roll) page 1, line 26 be reduced from \$2000.00 to \$1000.00, and that the collector is hereby authorized to accept payment in full satisfaction of said assessment at said valuation.

RETURN OF AN ELECTION, held on the 6th day of January, A. D. 1912, in Common School District No. 32, at Milam schoolhouse, in the county of Sabine, state of Texas, for the purpose of determining whether or not a special tax of 20 cents on the \$100 valuation of all taxable property in said district subject to taxation, shall be levied and collected for the purpose of supplementing the State school fund apportioned to said district.

THE RESULT OF THE VOTES IS AS FOLLOWS:

There were cast "For the Tax"..... 28 votes.

There were cast "Against the Tax"..... 24 votes.

On this the 8th day of January, 1912, came on to be heard the return of an election held on the 6th day of January, 1912 in Common School District No. 32 of this county upon the question of determining whether or not a special tax of 20 cents on the \$100 valuation of all taxable property in said district shall be levied and collected for the purpose of supplementing the State school fund, and it appearing that said election was in all respects legally held and that said returns were duly and legally made and that there were cast at said election 52 votes, of which number there were cast, "For the Tax" 28 votes, "Against the Tax" 24 votes; and it appearing to the court from said returns that a majority of the qualified property tax paying voters of said district voting at said election voted in favor and for said Tax. The court does hereby declare the said Tax to have carried in said District, and that this court is authorized to levy and have assessed and collected said Tax.

We, the undersigned officers, holding an election on the 6th day of January, 1912 in Common School District No. 32 of said county upon the question of issuing \$1300 of schoolhouse bonds for said district, running ten years, with option of redemption after three years, and bearing 5 per cent interest, and levying a tax on all taxable property in said district sufficient to pay the current interest on said bonds and provide a sinking fund sufficient to pay the principal at maturity, hereby certify that at said election there were cast 53 votes, of which number there were cast:--"For the Bonds" 26 votes. "Against the Bonds" 27 votes. Majority against the Bonds, 1 vote.
