Whereas, at an election held for the purpose on the 23rd day of March, 1912, a majority of the qualified property taxpaying voters of Common School District No. 17 of this county, voting at said election voted in favor of the issuance of the bonds hereinafter described, and in favor of the tax hereinafter levied.

It is therefore ordered by the Commissioners' Court of Sabine County that the bonds of said countypto be called "Common School District No. 17 Schoolhouse Bonds" be issued on the faith and credit of Common School District No. 17 of said County, as established by order of the Commissioners' Court of said county passed on the 24th day of September, 1906, which is of record in the minutes of said court on page 438 of Book "I", for the purpose of providing funds to be expended in payment of accounts legally contractrg in constructing and equiping a public free school building of wood material. Said bonds shall be numbered consecutively from one to ten, dollars each, aggregating one thousand \$1000) dollars. They shall be dated April 10th 1912, and shall become due and payable 20 years after date, with option of redempti after 10 years. They shall bear interest at the rate of 5 per cent per annum payable annually. on April 10th of each year. Principal and interest shall be payable upon presentation and surgender of bonds or proper coupons in lawful money of the United States at First National Bank, Hemphill, Texas. The said bonds shall be signed by the County Judge, countersigned by the County Clerk, and registered by thr treasurer, and the seal of the Commissioners' Court shall be impressed upon each of them. The fac simile signatures of the County Judge

and County Clerk may be lithographed, engraved or printed on the coupons. It is further ordered by the court that, to pay interest on said bonds and create a sinking fund sufficient to discharge them at maturity a tax of and at the rate of 15 cents on each \$100 of the assessed valuation of all property subject to taxation in said Common School District No. 17 of this County shall be annually levied, assessed and chleoted upon said property until said bonds, with interest, are paid, and said is here now levied for the year 1912.
