Present and presiding Hon. T. R. Smith County Judge, L. A. Jordan Commissioner Precinct No. 1, W. J. McDaniel Commissioner Precinct No. 2, S. H. Hall Commissioner Precinct No. 3, M. B. Carter Commissioner Precinct, No. 4, H. J. Solly, Sheriff, and W. R. Hyden, Clerk.

Court being duly opened by proclamation of the Sheriff, the following among other business were had to wit:

#### RETURNS OF AN ELECTION

On this day came on to be considered the returns of an election held on the 6th day of April, 1912, in Common School District No. 29, of this County upon the question of determining whethwe whether or not a Special Tax of 20 cents on the \$100 valuation of all taxable property in said district shall be levied and collected for School purposes, and it appearing that said election was in all respects legally held and that said returns were duly and legally made and that there were cast at said election 17 votes of which number there were cast " For the School Tax" 17 Votes.

"Against the School Tax" 00 Votes.

And it appearing to the court from said returns that a majority of the qualified property taxpaying voters of said district, voting at said election, voted in favor of levying said tax, therefore the court does hereby declare the said carried in said district, and that the court is authorized to levy and said tax.

Beginning at a point where the South boundary line of Sec. No. 3, T. C. Ry Co. intersects the boundary line between Sabine and San Augustine counties. Thence Easterly with the South boundary line of said Sec. No. 3, to its S. E. cor. on the West boundary line of Sec. No. 1, H. T. & B. Ry Co. Thence northerly with the west boundary line of said Sec. No. 1, to its N. W. Cor. same being the S. W. cor. of the William Isaacs league. Thence Easterly with the S. Bdry line of said Isaacs league to one of said leagues S. E. Cor's. Thence N. Easterly with the S. E. Bdry line of said Isaacs league to another of its S. E. Cor's. Thence Northerly with the said Isaacs line to its most easterly corner, same being the N. W. cor. of the Joseph Mott league. Thence North-westerly with the line of the said Isaacs league, the east boundary of the Willis Murphey and the West boundary of the N. Mackey league to the N. W. cor. of said N. Mackey league. Thence Easterly with the N. Bdry line of said Mackey league to the most South-easterly corner of said Murphey league. Thence N. Westerly with the E. Bdry line of said Murphey league to its North-east corner. Thence South-westerly with the N. Bdry line of said Murphey league to the most Southerly corner of the Wm. A. Thompson survey. Thence N. Westerly with the South-west boundary line of said Thompson survey to where said line intersects the boundary line between Sabine and San Augustine Counties. Thence Southerly with said boundary of said Counties to the place of beginning.
