It was ordered by the court that Dr. W.T. Arnold be appointed County health officer.

It was ordered by the court that J.L. Ragan, J.D. Fuller W.M. Davidson be allowed \$3.00
each for making examination of F.M. Wallace mare at Geneva, Texas. It was ordered that
Clyde Nethery be allowed .50 cents for taking acknowledgements.

It was ordered by the court that the rendition of 500 acres of the Henry Canfield
owned by East Texas Oil Gas & Mineral Co. be reduced from \$10.00 to \$7.00 per acre
and clerk was ordered to notify Tax Collector.

It was ordered by court that the Clerk have published in both County papers for
two weeks a notice advising persons from carrying off County wood and County Attorney is

It is ordered by the Court that County health officer ascertain just who have been exposed to affected parties and have them quarantined.

It is ordered by the Court that Chas Moore be allowed two days at \$2.50 per day for attending Mr. Cade White.

It is ordered by the Court that Dr. J.W.Smith be allowed \$15.00 for attending Mr. Cade White.

It is ordered by the Court that Dr. J.W.Smith wire for a supply of Auto Meningitis Serum at expense of Court.

Ordered that Court adjourn and each officer be paid his per diem.

County Health Officer, Sabine County, Texas.

I, Dr. W.T. Arnold Jr. do solemnly swear that I will faithfully and impartially discharge and perform all the duties incumbent upon me as County Health Officer of Sabine County, Texas, according to the best of my skill and ability, agreeably to the Constitution and laws of the United States and of this State and I do further solemnly swear that since the adoption of the constitution of this State, I being a citizen of this state, have not fought a duel with deadly weapons within this state nor out of it nor have I sent or accepted a challenge to fight a duel with deadly weapons nor have I acted as second in carrying a challenge or aided, advised or assisted any person thus offending; and I further more solemnly swear that I have not directly or indirectly paid offered or promised to pay, contributed or promised to contribute any money or valuable thing or promised any public office or employment as a reward for the giving or withholding of my appointment as County Health Officer of Sabine County, Texas, and I further more solemnly swear that I will not directly or indirectly interested in any contract with or claim against the County except such warrants as may issue to me as fees of office. Beginning at the N.E. Cor. of the Shradrack Morris league. Thence westerly with the N. Bdr'y. line of said Morris league to its N.E. Cor. Thence Southerly with the E. Bdr'y. line of the J.A. Thence south easterly with the N.E. line of said Hill survey to the S.W. Cor. of the Curtis M. Jackson survey. Thence Northerly with the W. Bdr'y line of said Curtis M. Jackson survey to its N.W. Cor. Thence Northerly with the E. Bdr'y. line of the James S. Odgen survey to its N.E. Cor. on

on the S. Bdr'6. line of the John B. Gaines survey. Thence S. 81 E. with the S. Bdr'y. line to the John B. Gaines survey to its S.E. Cor. Thence N. 9 E. with the E. Bdr'y. line line of said John B. Gaines survey to its N.E. Cor. on the S. Bdr'y. line of the James Gaines league. Thence S. 81 E. with the S. Bdr'y. line of said James Gaines league to its S.E. Cor. on the Sabine river. Thence down said river with its meanders to the place of beginning.

By making the change suggested you will not interfere with any land now included in another district. The portion of the Moses Hill Survey south of the Polo Cocho which this change will place in the district No. 19, is not included now in any district.
