The original bond given by the First National Bank of Hemphill, Texas as depository for the permanent school fund for \$12,500.00 was raised to 20,000.00 and the following bond was approved:

The State of Texas,

County of Sabine. Know all men by these presents: That we, the First National Bank of Hemphill, Texas, as Principal and A.M.Jones, G.E.Pratt, W.T.Morris, J.A.Watson, W.F.Goodrich, as sureties are held and firmly bound unto J.B.Lewis County Judge of Sabine County, Texas, and his successors in office in the sum of Twenty Thousand (\$20,000) Dollars for the payment of which we hereby bind ourselves and our heirs, executors and administrators jointly and severally by these presents.

The condition of the above obligation is such, that whereas the above bounden First National Bank of Hemphill, Texas has offered the highest bid on daily balances (3 per cent) and was on February the 13th 1913 chosen by the Commissioners Court as depository of the funds of Sabine County, including school funds for the term of two years, beginning February the 13th 1913.

Now, therefore if the First National Bank of Hemphill, Texas, shall safely keep and faithfully disburs the school fund according to law and pay such warrants as may be drawn on said funds by competent authority, and shall account for them at the interest thereon at the rate of three per cent per annum, calculated on daily balances to the Commissioner Court of said County and to the State Supt of Public instructions as required bylaw, then this obligation shall be void; but otherwise it shall remain in full force and effect.

By order of the Court the following petition for maintenance tax was allowed.

The State of Texas,

County of Sabine.

To the Hon. Commissioners Court of Sabine County:

We the undersigned qualified property tax paying voters of Common School District No. 36 in Sabine County, Texas, represent to said Honorable Court that there is now in force and effect a special maintenance tax of 20 cents on the one hundred dollar valuation of taxable property in said district: that the said maintenance tax of 20 cents as same now is levied and collected in said district is not sufficient for the proper maintenance of the school in said district; that we the undersigned legally qualified property tax paying voters of said Common School District No. 36 in said Sabine County, Texas, desireing to tax ourselves for the purposes of suplimenting the State School Fund apportioned to said district, hereby petition this Hon. Commissioners Court that an election be held in Common School District No. 36 in said Sabine County, Texas, to determine whether or not the said local maintenance tax of 20 cents on the one hundred dollars valuation of taxable property in said District as said tax now exists, shall be increased to 50 cents on the one hundred dollars valuation of,

and that I will faithfully perform all the duties required of me under the constitution
and laws of this State, so help me God.
