

Court Met Sept. 8th. 1913 in regular session with the following present: Hon. J.B. Lewis, presiding, Geo. W. Neren, W.J. McDaniel, S.H. Hall and A.T. Mathews Commissioners, H.J. Solly Sheriff and F.P. Adams Clerk.

The Court was opened by proclamation of the Sheriff.

The following petition for a stock law election was presented to the Court and was granted and the date of the election set to be held on the 25th. day of October A.D. 1913 with the regular appointed officers of the precinct appointed to hold same in accordance with the law relative to such elections.

To the Honorable Commissioners Court of Sabine County, Texas:

We the undersigned resident citizens and free-holders of the following described subdivision of Sabine County, Texas, hereby petition your honorable body to order an election to be held in the following described subdivision of Sabine County, Texas, for the purpose of enabling the free-holders of such subdivision of Sabine County, to determine whether hogs, sheep and goats shall be permitted to run at large in such subdivision of Sabine County.

Said subdivision of Sabine County is bounded and described as follows, to-wit:-

Beginning on the South boundary line of the M. Ussery survey where the said line crosses the Sabine and San Augustine County line. Thence East with the South line of the M. Ussery survey to the West line of the D. Renfro league. Thence West with D. Renfro's west league line to the S.W. corner of the D. Renfro league. Thence East with the South line of the D. Renfro league to the S.W. corner of fifty acres owned by Mrs. W. W. Bickley. Thence North with the West line of said 50 acre tract to its North West corner. Thence East with the North line of said 50 acre tract to Lobenells creek. Thence up said Lobenells creek to the North West corner of a 10 acre tract owned by W.S. Bickley. Thence East with the North boundary line of said 10 acre tract to its North East corner, on corner of 68 acre tract owned by W.S. Bickley. Thence South East and East with North line of said 68 acre tract to North East corner of said 68 acre tract. Thence Southward with the East line of said 68 acre tract to its South East corner on David Renfro's South league line. Thence East along David Renfro's South line to the road leading to Sexton. Thence North with said Sexton road to the S.W. corner of 59-1/4 acre tract owned by J.D.

Baldree. Thence Eastwardly with the South line of said Baldree's 59-1/4 acre tract to its South East corner. Thence North with said Baldree's East line to his corner on old divisional line of the David Penfro League made for W.A. and Mary Wall. Thence East with said old divisional line to Mill Branch, same being Henry Cordray's West boundary line. Thence Northerly with said branch and Henry Cordray's west line to Cordray's North West corner. Thence Eastwardly with Henry Cordray's North line to his North East corner. Thence continuing with said Henry Cordray's East line to his North West corner of tract owned by J.W. Minton. Thence with J.W. Minon's North line to the West line of the Wm. Ber. shears survey. Thence North with the West line of the Wm. Beshears survey to its North West corner. Thence East with the North line of the Wm. Beshears survey to the North east corner of a tract owned by J.W. Minton. Thence South with the east line of J.W. Mintons tract to the Packer Branch. Thence down the Packer Branch to the Milam and Sexton road. Thence Southerly with said Milam and Sexton road to a point South of Peter Gellatlys where the road leading to Sneeds old Mill leaves the Milam and Sexton road. Thence with said Sneeds old Mill road to the North line of a tract owned by Everett McGow near a small rocky branch. Thence West with said Everett McGow's north line to his North west corner. Thence South with Everett McGow's West line to the Geneva and Bronson road. Thence with said Geneva and Bronson road to the Pologocho Creek at a point near Sneeds old mill. Thence up the Pologocho Creek to the San Augustine County line. Thence up the San Augustine County line to the place of beginning.

It is ordered by the Court that the County Clerk be and he is hereby appointed Purchasing Agent of Sabine County. It is his duty to purchase all of the stationery and office supplies for each officer of the County and no account will be allowed until it is signed by him in his official capacity.

On account of the Stock Law election that was ordered for the Tebo subdivision not being held as ordered it is hereby ordered by the Court that same be held on the 29th day of October A.D. 1913 in accordance with the law relative to such elections.

Court recessed to meet Sept. 9th. 1913 at 9 o'clock A.M.

Court met in pursuant to adjournment with all members present as of the 8th. except Commissioner W.J. McDaniel.

The following petition being presented to the Court it is ordered that the ~~dated~~ notes of Red Oak Grove School District be changed to read as follows:-

To the Honorable Commissioners Court of Sabine County:

We the undersigned partons and free-holders of the Red Oak Grove School District respectfully ask your honorable Court to make the following changes in the boundary lines of the Red Oak Grove School District, as follows to wit:

Beginning at or near the N.W. corner of the J.J. Mattor old place, and thence South along the East boundary line of the Cummings Singleton tract to the N.E. corner of the S.F. Hankla 32 acre survey. Thence West along the North line of said survey between S.F. Hankla and Jack Earles to the N.W. corner of said S.F. Hankla survey, so as to include his premises and improvements. Thence South to the Milam and San Augustine road.

Thence West along said road to the corner of S.F.Hankle and R.A.Blount on said road. Thence in a South Westerly direction along the said S.F.Hankle North boundary line to his N.W. corner. Thence down his S.W. boundary line to where said line intersects the West boundary line of J.J.Hankle. Thence along said J.J.Hankle line to his S.W. corner including the 75 acre survey allotted to E.R.Meador. Thence South to the S.W. corner of the E.R. Meador 75 acre survey, intersecting the North boundary line of the Rosevine and Chappel School District. Thence East along the line of said 75 acre survey to the corner of the Fuller survey. Thence South down the line of S.J.Meador to the intersection of the line of the Gus Cotton place. Thence East along the S.B. line of the said S.J.Meador to the Laboneola Creek. Thence down the creek to the S.W. corner of the F.M.Errington tract. Thence along the S.B. line of the F.M.Errington survey to his S.E. corner. Thence South along the line of the Bill Weathered tract on his East boundary line to the intersection of the J.A. Scurlock tract, known as the Bill Gashy tract of land. Thence East along the said South boundary of the J.A. Scurlock tract of land to his S.E. corner, same being the S.W. corner of the Alfred Canton tract of land. Thence East along his South boundary line to his S.E. corner. Thence in an Easterly direction to the S.E. corner of the Geneva Independent School District. Thence North along the West boundary line of the Geneva Independent School District to the place of beginning.

We further ask that your Honorable Court grant us the privilege of becoming patrons of the Geneva Independent School District, for the following good and sufficient reasons to wit:

First: Because it is very inconvenient for us to send to the Red Oak Grove School, because it is more than four miles from the Southern portion of the District to the School house, the house being situated in the extreme Northern part of the District, and we can get to the Geneva School house on an average of about one and one half miles, and for the reasons stated, we desire to be taken out of the Red Oak Grove District and placed in the Geneva District.

It is ordered by the Court that Four Hundred (\$400.00) Dollars be appropriated to be expended in supplementing the salary of a U.S. Agricultural Agent for Sabine County. Said \$400.00 to be paid over to the U.S. Agricultural Agent for this District in Warrants of \$40.00 per month for Ten months and payments to begin Sept. 15th, 1913 or as soon as the work is begun by the agricultural agent in Sabine County. Said Warrants to be issued monthly by the County Clerk out of the General County Fund and payable on the endorsement of the County Judge.

The Court ordered that G.F.Strickland be allowed a discount of \$10.00 on his convict bond if paid at once in cause No. 925 State of Texas vs. G.F.Strickland.

The Court allowed S.W.King, R.S.McDaniel, and F.Berryman the sum of \$6.00 each for two days attendance in County School Trustees work and W.S.Smith was allowed \$3.00 for one days work in the same cause.

The Court allowed all accounts as per accounts allowed ledger.

The Court adjourned to meet at next regular meeting.
