

Commissioners Court met in regular session Oct. 13th, 1913 with the following members present: Hon J.B. Lewis, Judge presiding, Geo. W. Neren, W.J. McDaniel, S.H. Hall and A.T. Mathews, Commissioners, H.J. Solly Sheriff and F.P. Adams Clerk.

The following matters together with others were had to-wit:-

The Court ordered that Felix Payne be allowed a discount of \$5.00 on his convict bond.

The Court recessed until Oct. 14th, at 9 o'clock.

The Court was called together with all present as of the 13th.

It is ordered by the Court that the tax Rolls this day presented by J.D. Woods, Tax Assessor of Sabine County Be approved and the clerk ordered to issue warrant to J.D. Woods for \$66.13 the balance due him by the County for assessing taxes.

It is ordered by the Court that H.J. Solly, Tax Collector be charged with the Tax Rolls of said County for the year 1913 under different funds as follows to-wit:

The following petition for road was presented to the Court and allowed.

To the Honorable Commissioners Court, Sabine County, Texas, Hemphill:-

We the undersigned citizens of Sabine County, Texas, and patrons of the San Augustine and Brookeland public road do hereby petition your honorable body to establish a public road to lead from a point on the San Augustine Brookeland road about three miles from Brookeland via Geo. Bells place to Brookeland, Texas. This road will make a more direct route to your petitioners Post Office, Railway Station, Church, School and etc., and will shorten the route by two miles.

The road to begin at a point on the San Augustine and Brookeland road at an old road leading by G.A.Bells place, thence toward Brookeland on said old road to Trout Bayou to the W.A.Hooks and W.W.Hamilton land line, thence with said line to Lickim Creek, thence with W.A.Hooks and J.J.Willis dividing line to the John O.Bell line, thence with Jno. O.Bell and W.A.Hooks line to W.A.Hooks and Will Baker line, then down Bakers and Allons line, thence with Bakers and Jno. McClelland line to Brookeland and Hemphill road.

The following petition for increase of local School Tax in Common School District No. 9 was presented to the Court.

The State of Texas, County of Sabine.

To the Honorable Commissioners Court of Sabine County: We, the undersigned qualified property tax paying voters of Common School District No. 9 in Sabine County, Texas, represent to said honorable Court that there is now in force and effect a special maintenance school tax of .20 cents on the One hundred dollars valuation of taxable property in said district; that said maintenance tax of .20 cents, as same now is levied and collected in said district, is not sufficient for the proper maintenance of the school in said district; that we, the undersigned legally qualified property tax paying voters of said Common School District No. 9 in said Sabine County, Texas, desiring to tax ourselves for the purpose of supplementing the State School fund apportioned to said District, hereby petition this Honorable Commissioners Court that an election be held in said common school district No. 9 in said Sabine County, Texas, to determine whether or not the said local maintenance tax of .20 cents on the one hundred dollars valuation of taxable property in said district, as said tax now exists, shall be increased to .50 cents on the one hundred dollars valuation of taxable property in said district for said purpose.

The Court ordered the Clerk to issue warrants for \$6.00 each month to Mrs. Beckie Fuller for taking care of Miss Mannie Howard, to be paid monthly until otherwise instructed.

The Court ordered the clerk to issue to each officer his per diem.

The Court adjourned to meet at next regular meeting.
