

The Commissioners Court met in quarterly meeting May the 11th, 1914 with the following members present: Hon. J.B. Lewis, County Judge, presiding; Geo. W. Nerran, Com. Prec. No. 1, W.J. McDaniel, Com. Prec. No. 2, S.H. Hall, Com. Prec. No. 3 and A.T. Mathews, Com. Prec. No. 4, H.J. Solly, Sheriff and F.P. Adams, Clerk. The following matters together with others were had to wit:

The Court ordered that the school House in School Dist. No. 26 be sold to the highest bidder and the name of the District be changed from Curry Hill to Bethlehem and a new school building be built.

The Court ordered that the following petition for a new school District be granted:

Bayou, Texas, 4/13/14 TO THE HON. COMMISSIONERS COURT: MAY TERM 1914.

We your undersigned petitioners respectfully ask you to create a school district in Sabine County within the limits as shown by the plat and field notes as per herewith attached. The territory herein embraced being a part of Caney District No. 10 also a part of District No. 12. We recommend that the new school district be named Temple and also represent that we are citizens of said Caney District No. 10 and of District No. 12 and that each petitioner is a parent or guardian of the number of children opposite each respective name. We also further represent that the creation of the new school district will not impair either school district from which the described territory is sought to be taken below the number of acres required by law to form a school district and further that on account of a number of your petitioners residing so far from Caney School that it is almost impossible to send the children to school which is sufficient without any further cause for creating a new school district as represented in our petition. We therefore pray that your Hon. Court act favorably on this petition and that you have said District numbered and trustees for said District appointed and our legal prorata of funds apportioned to said school for the ensuing scholastic year, for which we will ever pray:

J.M. Slocum appeared before the Court and stated that he had a horse that he had reasons to believe had the Glanders and upon this information the County Judge appointed J.E. Partin, S.P. McElroy and V.E. Rathbone as a commission to make the necessary examination and if necessary to kill the horse. The Commission found that the horse had the glanders and he was killed and the Court allowed J.M. Slocum \$100.00 for the value of the horse and each of the commission \$3.00 per day for the time spent in making the examination and O.F. McElroy was allowed \$5.00 for killing the horse.

The Court ordered the clerk to instruct the County Treasurer to transfer any sum that may be in the Jail Bond Fund to the Road and Bridge Fund.

The Court ordered the clerk to issue warrant to S. H. Truitt, Sheriff of Shelby County for the amount of his account for bringing Mrs. Torrence to Sabine County, if the account is sworn to and itemized.

On this day came on to be considered the returns of an election held on the 25th day of April 1914 in common School District No. 25 of this County upon the question of increasing the school tax to 25 cents on the one hundred dollars valuation and it appearing that said election was in all respects legally held and that said returns were legally made and that there were cast in said election the following vote-

Willis, is hereby appointed presiding officer for said election, and he shall select two judges and two clerks to assist him holding the same, and he shall, within five days after said election has been held, make due return thereof to the Commissioners Court of this County, as is required by law for holding a general election.

The ballots for said election shall have written or printed thereon the following:

For Increased School Tax.
Against Increase School Tax.

All persons who are legally qualified voters of this State and of this County and who are resident property taxpayers in said district shall be entitled to vote at said election.

The Sheriff of this County shall give notice of said election by posting three notices at three public places in the said district for three weeks before the election.

Thence with an old road to Frank Ellisons place, thence with an old road to what is known as that Horton place, thence with the Bronson and Geneva road to Tebo Creek at Fullens bridge, thence up said Tebo creek with its meanders to place of beginning, to determine wither or not hogs, sheeps and goats shall be allowed to run at large within the above described territory or subdivision of Sabine County, and

Whereas a majority of the legally qualified voters who are freeholders residing within said territory or subdivision of said County, voted in said election in favor of the adoption of the stock law within said territory, at said election.

Now therefore, I, J. B. Lewis, in my capacity as County Judge, of Sabine County hereby declare the said stock law adopted within said above described territory, or subdivision of said County, by reason of said election, and I, hereby further declare that after thirty days from the date of this proclamation, it shall be unlawful for any sheep goats or hogs, to be allowed to run at large within said above described territory.
