

Commissioners Court met in regular monthly meeting July 13th. 1914 with the following members present:-

Hon. J.B. Lewis, Judge Presiding, Geo. W. Nerren, Com. Prec. No. 1, W.J. McDaniel, Com. Prec. No. 2, S.H. Hall, Com. Prec. No. 3, A.T. Mathews, Com. Prec. No. 4, H.J. Solly, Sheriff and F.P. Adams, Clerk.

The Court was duly opened by proclamation of the Sheriff.

The following matters together with others were had to wit:-

The following petition for road was granted-

We the undersigned citizens of Sabine County, respectfully petition the Commissioners Court to now make the new road permanent with the understanding that the Temple Lumber Company extend it straight into Pineland.

Beginning at the dividing line of Jack Woods and Mrs. Martins, thence with Mrs. Martins East line to the North line of the David White, thence in an Easterly direction with the North line of the David White and South line of the Thomas Lindsey and continue on a straight line to Pineland.

The Court allowed S.P. McElroy \$5.00 for killing and burning the M.L. Whitehead mule that was condemned by the Com. appointed by the County Judge, the said mule being afflicted with Farcy.

The following petition for a road was granted by the Court:-

We the undersigned signers petition your Hon. Body of Commissioners to grant a Public road leading from 1/2 mile West of Pineland at the tram road crossing to M.S. Grays, thence to Jim Lakeys place, thence to the County line intersecting the West Jasper road at the County line one half mile West of Jim Lakeys.

Accounts were allowed as per accounts allowed ledger.

The Court ordered the Clerk to Issue a warrant for \$75.00 to the Sabine Citizen Telephone Co. for three telephones subscribed for by the Court.

Geo. Morris was appointed Overseer of the Homer and Bronson road.

Court allowed W.R. Davidson .35 cents to pay for having the grass mower sharpened.

The Court ordered that a New School Dist. be created to be known as Six Mile School Dist. No. 37 and to be bounded as follows-

County of Sabine. : Field Notes of Six Mile Common District No. 37. in Sabine County, Texas.

Beginning at the extreme east corner of the Wm. M. Arledge survey on the north boundary line of the Kli Low League.

Thence S. 63 W. with N.B. Line of Eli Low League to the N.E. cor. of a subdivision of 588 acres of land originally surveyed for J.G. Low.

Thence S. 27 E. with east line of said 588 acres to the S.W. cor. of subdivision No. 2 containing 149 acres, in said Low League.

Thence N. 63 E. with S.B. Line of subdivision No. 2, to the N.E. Cor. of subdivision No. 3. Thence S. 27 E. to S.E. Cor. of No. 3.

Thence N. 63 W. to the N.E. Cor. of subdivision No. 4.

Thence S. 27 E. with the east line of block No. 4, to the N.W. Cor. of a survey owned by G.H. Williams.

Thence N. 63 E. to the N.E. Cor. of said Williams survey.

Thence S. 27 E. with the east line of said William's survey to the S.E. cor. on the south boundary line of the Eli Low League.

Thence with the south boundary line of the Eli Low League to the N.E. Cor. of H.E. & W.T.R.R. Sec. No. 3.

Thence S. 27 E. with the east boundary line of same to its S.E. Cor. on N.B. Line of Wm. F. Clark League.

Thence S. 63 W. with the N.B. line of said Clark to one of its original corners.

Thence N. 27 E. to the extreme N.E. Cor. of the Clark League.

Thence S. 63 W. with the N.B. line of Clark's League to the N.E. Cor. of John Gallion League.

Thence S. 27 E. with the E.B. Line of John Gallion League to its S.E. Cor.

Thence S. 63 W. with John Gallions S.B. Line to its S.W. Cor. on Wm. Kennards E.B. Line.

Thence S. 27 E. with Wm. Kennard's E.B. Line to the County line between Sabine and Newton Counties.

Thence with said County line westward to the W.B. Line of said Kennards League.

Thence N. 27 W. with Kennard's W.B. Line to its N.W. Cor.

Thence N. 71 E. with Kennard's N.B. Line to south corner of Cadwalter Davis League.

Thence N. with Cadwalter Davis E.B. Line to S.W. Cor. of Walter Hughes League.

Thence N. 63 E. with Walter Hughes S.B. Line to S.E. Cor. of a subdivision survey made for F.F. Dickery.

Thence N. 27 W. with divisional line of Walter Hughes League to the S.W. Cor. of a survey of 21 acres made for D.B. Easley.

Thence N. 63 E. with S.B. Line of said 21 acres to its S.E. Cor.

Thence N. 27 E. to its N.E. Cor.

Thence N. 45 W. to said divisional line.

Thence N. 27 W. with said divisional line to the N.B. line of said Walter Hughes League.

Thence N. 63 E. with said N.B. Line to one of Wm. Arledge's S.W. Cor. on N.B. Line of said Hughes League.

Thence Northerly with said Arledge survey to its N.W. Cor. on S.B. Line of H. Milligans survey.

Thence east with the S.B. Line of said Milligans survey to its S.E. Cor.

Thence north with Milligans E.B. Line to its N.E. Cor. on Henry Nichols S.B. Line.

Thence east with Henry Nichol's S.B. Line to its S.E. Cor. on Jesse Lows W.B. Line.

Thence Southerly with Jesse Lows W.B. Line to one of his S.W. Line to one of his S.W. Corners on Wm. Arledge N.B. Line.

Thence east with Jesse Low's S.B. Line to the place of Beginning. Containing approximately 18,526 acres of land.
