

Commissioners Court met in Special Called meeting Sept. 5th, 1914 with Hon. J.B. Lewis, presiding. Geo. W. Neuren Com. Prec. No. 1, W.J. McDaniel Com. Prec. No. 2, S.H. Hall Com. Prec. No. 3, and A.T. Mathews Com. Prec. No. 4. H.J. Solly, Sheriff and F.P. Adams, Clerk.

The Court was duly opened by proclamation of the sheriff and the following matters together with others were had to wit:

The Fairmount Common School Dist. No. 9 was divided into three Common School Districts with the following boundaries and names and numbers:

Field notes of Fairmount Common School District No. 9 as changed by order of the Commissioners Court.

Beginning on the N.E. line of the John Gallion League at the N.W. Cor. of the E.D. Downs 100 acre tract, deeded to Downs by Jessie McNaughton.

Thence Southerly with the W.B. Line of said 100 acre tract to Sandy Creek. Thence down Sandy Creek to N.W. Cor. of John Smith 100 acre tract. Thence southerly with the W.B. Line of said 100 acre tract to its S.W. Cor. Thence with its S.B. Line to the W.B. Line of the W.F. Clark League. Thence with the W.B. Line of the W.F. Clark League to its S.W. Cor. and N.W. Cor. of T.& N.O.R.Y. # 31. Thence Southeasterly diagonally across sec. # 31 to its S.E. Cor. and W.E. Cor. G.H. & S.A. # 2. Thence Southerly with E.B. line of G.H. & A. # 2. to the County line of Sabine & Newton Counties. Thence west with said County line westerly to where the W.B. Line of G.H. & S.A. # 14 crosses said County line. Thence Northerly with said Sec. # 14 and W.B. Line of John Gallion League to the N.W. Cor. of the John Gallion. Thence Easterly with the N.B. Line of the John Gallion League to the place of beginning. Containing approximately 6, 334 acres of land.

Field Notes of Six Mile Common School District No. 37. Established by order of the Commissioners Court.

Beginning at the S.W. Cor. of Sec. # 2 H.E. & W.T. Ry Co. Thence Northerly with said W.B. Line to the S.B. Line of Eli Low League. Thence Westerly to the S.W. Cor. of said Eli Low League. Thence Northerly with the W.B. Line of the Eli Low to the S.E. Cor. of S.T. Masons land thence Westerly and Northerly and easterly so as to include all of S.T. Masons land and back to the W.B. Line of Eli Low League. Thence Northerly to the N.W. Cor. of the Eli Low League on the E.B. line of Walter Hughes. Thence N. to N.E. Cor. of W. Hughes. Thence W. with Hughes N.B. Line to S.W. Cor. of Wm. Arledge. Thence N. with Arledge W.B. Line to H. Milligan's S.B. Line. Thence E. to S.W. Cor. of H.E. & W.T. Sec. 2. Thence Northerly with W.B. Line of said Sec. No. 2. to H. Nichols S.B. Line. Thence E. to N.E. Cor. Sec. 2. Thence S. with E.B. Line of said sec. # 2, to Wm. Arledge N.B. line. Thence W. with Arledges line to Arledge's N.W. Cor. Thence S. with Arledges W.B. line to W. Hughes N.B. Line. Thence E. with Hughes N.B. Line to his N.E. Cor. Thence with Hughes E.B. Line to N.W. Cor. Eli Low League. Thence Easterly with Eli Low's N.B. line to N.W. Cor. of a 1340 acre sub-division of said Low League. Thence Southerly with said Divisional line to the S.B. line of said Eli Low League including all of said Eli Low except 1340 acres on the east end. Thence easterly with said Eli Low S.B. line to the N.W. Cor. of D.L. Richardson Survey. Thence Southerly with said E.B. Line of Henry Canfield. Thence Westerly with N.B. Line of said Canfield to N.W. Cor. of same. Thence Southerly with W.B. Line of said Canfield to its S.W. Cor. Thence Easterly to N.W. Cor. of A.W. Canfield. Thence Southerly with W.B. Line of Canfield & Aurelia Russell to its S.W. Cor. Thence easterly with S.B. Line of said Russell to the N.W. Cor. of S.L. Dainwood. Thence Southerly with Dainwood's W.B. Line to N.E. Cor. Sec. 6. Thence Southerly with its E.B. Line to its S.E. Cor. Thence with its S.B. Line westerly to County line.

Thence with the County line to S.E. Cor. of Smith District. Thence with the Smith Dist. line northerly to the place of beginning. Containing approximately 6,950 acres of land.

Field Notes of Smith Common School District No. 15, as Established by order of the Commissioners Court.

Beginning where the County Line crosses W.B. Line of C.H. & S.A. R.R. Co. # 3. Thence easterly with Co. line to where said Co. line crosses the E. Bdy of the said Sec. # 3. Thence Northerly with said Sec. # 3 and T. & N.O. # 29, with their E.B. Lines to the S.B. Line of the Wm. Clark League. Thence easterly with said S. B. Line to the S.E. Cor. of said Clerk. Thence Northerly with the E.B. Line of said Clark to its N.E. Cor. Thence Westerly with N.B. line of said Clark to one of its N.E. Cor. at the S.W. Cor. of Sec. # 1, H.E. & W. T. Ry Co. Thence Northerly with the W.B. Line of said Section to the N.E. Cor. of said Clerk League. Thence Westerly with said N.B. Line of said Clark and the N.B. Line of the John Gallion Leagues to the E.B. Line of the Clark Common School Dist. Thence southerly with said Fairmount School Dist. to the place of beginning.

Containing approximately 6,420 acres of land.

The order heretofore made creating the Six Mile school District is hereby rescinded and is to be null and void and of no force or effect.

Accounts were allowed as per accounts allowed ledger.

J. C. Speights was given the contract to repair the burned portion of the County County Jail and is to be paid \$118.00, he being the lowest bidder.

H. A. Williams was given the contract of painting the Court House Roof and is to be paid \$62.00 he being the lowest bidder.

T. H. Browning was given the contract of painting the Jail Roof and is to be paid \$15.00, he being the lowest bidder.

It is ordered by the Court that the Road Commission given to H. J. McNaughton be cancelled and he be notified by the Clerk to turn in his commission and Jack McDaniel is hereby appointed to fill the place as Overseer of said road Precinct No. 48.

The Court allowed W.R. Davidson \$12.50 as salary for services as Janitor.

There being no further business the Court adjourned to meet at the next regular meeting. The officers were allowed their per diem.
