The order heretofore made not allowing convicts to be hired out is hereby rescinded and it is the order of this Court that all bonds be fixed at a minimum rate of \$9.00 per mo. and the County Judge by given the authority to fix the rate as high as \$15.00 per mo.

The Court allowed T.C. Spights \$100.00 out of R. & B. Fund for land and timber for Public Road purposes begining at N. of property bought of G.A. Methery for road purposes and extend to Nichols Creek.
