The Court was opened by proclamation of the Sheriff.

The following matters together with others were had to wit:-

W. M. Davidson and R.S.McDaniel having received the largest number of votes for County School Trustees they were duly declared elected by the Court.

A petition signed by W.H.Jackson and nine others asking that a change in a road as follows was granted- Heading from Rosevine School house by the way of W.F.Fullens and W.H.Jacksons places thence by the Holiness Church House and intersecting the Bronson and Geneva Road near the Noble Old Mill Place.

Accounts were allowed as per accounts allowed Ledger.

The Court granted a petition asking for a Stock Law Election to be held in a subdivision of Sabine County, signed by W.L.Fussell and two others and ordered that the election be held May the 20th. 1916 at Red Oak Grove School House in said subdivision.

The Court allowed J.W.Arnold \$7.50, W.T. Lee \$10.00 and Mr. Lightfoot \$10.00 as County Pension.

The Court ordered that Tom Bragg and Jess Mills be exempt from Road Duty for one year.

The Court ordered that the Clerk issue each officer his per diem.

There being no further business the Court adjourned to meet at next regular meeting.

Whereas, on the 8th day of November A.D. 1915 a petition was presented to the Commissioners Court of Sabine County, Texas, in due and legal form, asking that an election be held in the following described territory or sub-division of said County Texas to determine whether or not hogs, sheep and goats shall be permitted to run at large in said sub-division of said County, and WHEREAS SAID COMMISSIONERS COURT, on said date, to-wit: The 8th day of November at its regular session ordered that an election be held in said sub-division of said county for said purposes as follows, to-wit: Beginning at the Sneed old mill on the Pologocho creek at a point where the Geneva and Bronson public road said creek. Thence in a southerwesterly direction with said Geneva and Bronson public road to where to where present Geneva and Bronson public road leaves the old Geneva and Bronson Road at a point about 1/2 mile south of the residence of J.D. Edgar Thence with said old Geneva and Bronson road in a southerly direction to where said old road intersects the Hemphill and Bronson public road Thence in an easterly direction with said Hemphill and Bronson road public road to the west line of the land owned by J.H. Welch and on which he now resides thence south with said Welch's west line to his southwest corner Thence south with Jas Craig's west line to his S.W. corner Thence easterwardly with said Craig's south line to his S.E. corner thence north with Craig's east line to his N.E. corner thence west with Craig's north line to the south west corner of J.H. Welch's place on which he now resides Thence north with said Welch's east line to the Bronson and Hemphill Road thence easterwardly with said Hemphill and Bronson public road intersects the San Augustine and Hemphill public road thence ortherly from said point with an old road settlement road going by Burpee Buckleys place to Tebo creek Thence down said creek to Pologocho creek Thence up said creek to place of beginning.

NOW THEREFORE, I, J.B. Lewis, County Judge of said County, in my capacity as such hereby order that an election be held in said above described sub-division of said

Sabine County, Texas, on the 11th day of December 1915 Gravel Hill School House Common School District No 16 Sabine County Texas, in said sub-division of said Sabine County, to determine whether or not Hogs, Sheep and Goats shall be permitted to run at large within said territory or subdivision of said county, and I hereby appoint T.E. McLemore as presiding officer of said election. The Polls at said election will be opened and closed at the hours designated by law for the opening and closing polls at regular elections, and said election will be conducted as same as a regular election.

All persons who are qualified voters and free holders residing within said territory shall be permitted to vote at said election.
