

Commissioners Court met in regular quarterly session August 14th, 1916
with the following members present and presiding-

J.B.Lewis, County Judge, J.A.Ryden, Com. Beat No. 2, L.T.Halbert, Com.
Beat No. 3 and C.M.Bennett, Com. Beat No. 4, Jas. G. Barker, Sheriff and F.P.Adams
Clerk.

The Court was opened by proclamation of the Sheriff.

The following matters together with others were had to wit:

Accounts were allowed as per accounts allowed ledger.

The returns of a Special School Tax Election held in Common School Dist.
No. 6, Sabine County, asking for .10 cents increase of Tax on the \$100.00 valuation
came on to be canvassed and it showed the following result-

For Increase of Tax-----5 votes.

Against Increase of Tax----- "

The returns of a Special School Tax Election held in Common School Dist.

The Court ordered that the Milam and Bronson Road be changed so that it will run the land line between J.M.Baldree and G.O.Eddings and from Spring Branch to the school house yard so as to be on the land line between J.M.Baldree and W.F.Fullen.

Upon motion of J.A.Hyden and seconded by C.M.Bennett the Court allowed the Jury in the Lena Chambers Lunacy case \$3.00 each, the Sheriff and Clerk \$4.00 each and the Attorneys \$7.50 each, L.T.Halbert voting against the motion. It was carried.

The Court ordered that A.L.Harper be exempt from Road duty on account of a disabled Arm.

Whereas, on the 14th day of August, 1916, a petition was presented to the commissioner's court of Sabine County, Texas, asking that a special election be ordered by the court for the purpose of determining whether or not, hogs, sheep and goats shall be permitted to run at large within the following described subdivision of Sabine county, Texas, to-wit:

Beginning at the south east corner of the Joseph Walker survey. Thence in a northerly direction with the east line of the Joseph Walker survey to its north corner. Thence in a westerly direction with the north line of the Joseph Walker survey to its north west corner. Thence in a southerly direction with the west line of the Joseph Walker survey to its south west corner. Thence in an easterly direction with the south line of said Walker survey to its south east corner, the place of beginning, and Whereas, said commissioner's court on the 14th day of August, being in regular session, ordered that a special election be held on the 23rd, day of August 1916 for the purpose of determining whether or not hogs, sheep and goats shall be permitted to run at large within said above described subdivision of Sabine county.

NOW, THEREFORE, I, J.B.Lewis, in my capacity as county judge of said county hereby order that a special election be held in said above described subdivision of Sabine county, Texas, on the 23rd, day of August, 1916, for the purpose of determining whether or not hogs, sheep and goats shall be permitted to run at large within the above described subdivision of Sabine county, Texas; and it is further hereby ordered that the polls shall be opened for said election at the county court house, in the town of Hemphill.

R.H.Minton is hereby appointed presiding officer of said election, and L.R. Campbell and P.H.Browning are hereby appointed managers thereof.

All persons who are qualified voters under the constitution and laws of this State, and who are freeholders residing in the above described subdivision of said county, shall be entitled to vote at said election.
