

Commissioners Court met in regular monthly meeting Sept. 11-1916 with the following members present:-

J.B. Lewis County Judge, G.W. Nerren Com. Beat. No. 1, J.A. Hyden Com. Beat No. 2, L.T. Halbert Com. Beat No. 3 and C.M. Bennett Com. Beat No. 4, W.H. Pratt Constable Precinct No. 1 and F.P. Adams, Clerk.

The Court was opened by proclamation of the Constable.

The following matters together with others were had to wit:

Accounts were allowed as per accounts allowed Ledger.

Jas. G. Barker filed his bond as Sheriff of Sabine County, Texas, and the Court approved the Bond.

A petition signed by Jno. F. Adams and others asking for a Public road to be opened up from the Pineland Naval Stores Camp East of Pineland to Pineland Texas was presented to the Court and the Court ordered that the Road be granted.

A petition signed by H. Knox and others asking that a Public road be established from the West end of North Street in the town of Hemphill to the Knox Lumber Co. Mill was presented to the Court and the Court granted the Road with the understanding that the citizens pay the expense of the opening of the road.

Jas. G. Barker filed his 1915 delinquent Tax Report and the Court approved the same.

The Court approved the monthly reports of Jas. G. Barker for the months of April, May, June, July and August.

The Court approved the 1916 tax rolls as prepared by D.D. Woods, Tax Assessor.
