

Commissioners Court met in Special Called Session January the 29th. 1917 with the following members present:-

W. R. Cousins, County Judge.
D. A. Easley, Com. Beat No. 1.
J. A. Hyden, Com. Beat No. 2.
C. M. Bennett, Com. Beat No. 4.
C. B. Bright, Sheriff.
F. P. Adams, Clerk.

The Court was opened by proclamation of the Sheriff.

The meeting was called for the purpose of appointing school Trustees ~~and~~ and ordering a special School Tax Election for ~~and~~ School Dist. No. 33.

The following matters were had as follows together with others.

Accounts were allowed as per Accounts Allowed Ledger.

Upon the return of a Stock Law Election held at Milan, Texas, for said subdivision on January the 13th. 1917 the following result was declared-

Total number votes cast at said election-----27 votes.
For Stock Law-----12 votes.
Against Stock Law-----15 votes.

It appearing that a majority of the qualified voters of said subdivision desiring not to have the Stock Law, it is therefore declared that Stock be allowed to run at large in said subdivision.

The Court appointed the following School Trustees-

Six Mile School Dist. No. 37-----J. G. Low.
Beach Grove School Dist. No. 28-----W. S. Seale.
Lone Star School Dist. No. 5-----J. A. McElroy, C. W. McElroy and G. W. Nerren.
Curry School Dist. No. 26-----P. J. Walker.

Smith School Dist. No. 15-----Erwin Smith.

The appointment of these trustees being necessary on account of the resignation of the old trustees.

The Court ordered that a Special School Tax Election be held in Ridge Co. Line Common School Dist. No. 33 to determine whether or not a majority of the property tax paying voters of said District desire to increase the present school tax of .40 cents on the \$100.00 valuation to .50 cents on the \$100.00 valuation of all taxable property in said District.

The Court ordered that all road hands subject to Road Duty in Sabine County, be allowed to pay at the rate of \$1.00 per day for each day summoned to work the road in his respective road precinct.

Jas. G. Barker, Ex Sheriff, made his final report and the same was accepted by the Court and the Court ordered that the County Judge issue to each officer the amount due them on said account as their part of the costs reported.

The Court ordered that the County Surveyor go to the place of L. A. Fuller and make a survey of his property to determine whether or not his land touches the Stock Law Subdivision.

The Court allowed Allen Dennis \$3.50 for Poll Taxes paid that he had worked out on the Public Roads.

There being no further business the Court ordered the Clerk to issue each officer his per diem and the Court adjourned to meet at the next regular term.
