The report of the School Trustees of School District No. 9 on the sale of the old school building was approved by the Court.

The Court allowed J. W. Arnold \$5.00 as County Aid.

The Court Granted the High Way Marking Company the right to place markers or mile post on all Public High Ways in Sabine County.

Upon Motion made by Easley and seconded by Bennett to allow John Cook \$5.00 as County Aid, Hyden and Hargrove voted against said motion and Judge Cousins cast the decided vote against the allowance.

The Court allowed Jas. Giles \$10.00 and Mrs. Joe Horton \$5.00 as County Aid.

The Court rescinded the order relative to the Red Cross Club using the Rest Room.

The return of a special School Tax Collection held in a common School District No 32, came on to be considered and it was found that a majority of the property Tax paying Voters do not desire to Tax themselves for school purposes, it is therefore ordered by the Court that no extra levy be made in said District.

The County Officers reports for the past quarter were approved by the Court and the Clerk ordered to issue their salaries.

The Clerk was ordered to issue each Officer his per diem.

There being no further business the Court adjourned.
