County of Sabine. Notice is hereby given that an Election will be held on the 10th day of November, A. D. 1917, at the Ruddell School House in the Stock Law District known as Tebo Stock Law District, beginning at a point on the East boundary line of the Wm. Isaac League where the Bronson & Geneva road crosses said line. Thence W. with said road to where it intersects the Hemphill & San Augustine road near the church of God. Thence North with said road to the County line, near the town of Tebo. Thence S. W. With the County line to where it crosses Tebo Creek. Thence down said Creek to where it crosses the E. B. line of the William Isaacs League. Thence Northerly with said line to the place of beginning. To determine whether or not a majority of the legal qualified property tax paying voters of that District desires to prevent Hogs, Sheep & Goats from running at large. All persons who are legally qualified voters of this State and County and who are resident property tax payers in said District shall be entitled to vote at said election. Said election was ordered by the County Judge of this County by order made on the 9th day of October, A. D. 1917, and this notice is given in pursuance of said order.

NOTICE OF ELECTION.

WHEREAS, Senate Joint Resolution No. 12, adopted by the Thirty-Fifth Legislature of the State of Texas and approved by the Governor of said State on February 23, 1917, provides that there shall be submitted to the qualified voters of this State, at an election to be held throughout the State, on the third Tuesday in August, 1917, the same being the 21st day of August, 1917, the proposition to amend Article 16 of the Constitution of the State of Texas, by adding thereto at the end thereof another section to be known as Section 59, declaring that the conservation and preservation of all the natural resources of the State of Texas, are public rights and duties, providing for the creation of conservation districts, declaring such districts bodies politic and corporate, defining the authority of such districts, and conferring upon the legislature authority to pass laws with reference thereto, declaring that the legislature shall have authority generally to legislate for the purpose of conserving the natural resources of the State, fixing the time for the election for the adoption or rejection of said proposed constitutional amendment, making certain provisions for said election and the ballots thereof, and the method thereof, directing the issuance of the proclamation therefor, prescribing certain duties of the Governor of the State, and making an appropriation, to defray the expenses of such proclamation, publication and election.

And whereas, in conformity with said joint resolution and the constitution and laws of this State, the Governor of this State has issued his proclamation, embodying the provisions of said joint resolution, directing that said election be held throughout the State, on the third Tuesday in August, 1917, the same being the 21st day of August, 1917.

Now, therefore, it is ordered by the Commissioner's Court of Sabine County, Texas, that said election to determine whether the said proposed amendment to the Constitution of the State of Texas, shall be adopted or rejected, be held in each of the regular voting precincts of said Sabine County, Texas, at the regularly designated voting places thereof, on the said third Tuesday in August, 1917, the same being the 21st day of August, 1917, that the said election be held by the regularly appointed and qualified election officers of said voting places, and that said election and returns of same shall be held and made in strict conform-

ity with all the provisions of the general election laws as amended and in force at the time said election is held, and governing in all respects as to the qualifications of electors, the method of holding such election, and in all other respects as far as such election laws can be made applicable. All persons who are qualified electors for members of the legislature are eligible to vote. The Sheriff of this County shall give notice of this election by posting a copy of this order at each precinct for at least thirty days before the day of election. The ballots for said election shall have written or printed thereon the following: For the Amendment to Article 16 of the Constitution of the State of Texas, providing for conservation districts, the creation of such districts, and their government and regulation.
