

Commissioners Court met in Special Session July 20th 1918 with the following members present-

The Court was opened by proclamation of the Sheriff.

The Court approved the Road Map as prepared by L. Acker, County Engineer and the Court ordered the Clerk to issue to L. Acker a County Warrant for same.

Accounts were allowed as per Accounts Allowed Ledger.

Upon the returns of a Special School Tax Election held in Common School Dist. No. 38 on July 13th. 1918, the following result was declared-

For School Tax-----5 votes.
Against School Tax-----0

It is therefore ordered by the Court that a tax of and at the rate of .50 cents on the \$100.00 valuation on all taxable property in said District No. 38 be levied, assessed and collected.

Upon the returns of a special school tax election held in Common School Dist. No. 23 on July 13th. 1918, the following result was declared-

For School Tax-----15 votes.
Against School Tax-----0

It is therefore ordered by the Court that a tax of and at the rate of .50 cents on the \$100.00 valuation on all taxable property in said District No. 23 be levied, assessed and collected.

Upon the returns of a Special School Tax Election held in Common School Dist. No. 37 on July 13th. 1918, the following result was declared-

For School Tax-----5 votes.
Against School Tax-----0

It is therefore ordered by the Court that a tax of and at the rate of .50 cents on the \$100.00 valuation on all taxable property in said District No. 37 be levied, assessed and collected.

Upon petition of the required number of property tax paying voters in Common School Dist. No. 12 asking that an election be held in said District for the purpose of determining whether or not a majority of the tax paying voters desire to increase the school tax in said Dist. ~~to~~ to .50 cents on the \$100.00 valuation to supplement the State apportionment for school purposes in said Dist. the Court ordered that an election be held in said District on the 17th day of August 1918 at the school house in said District and that V. B. Youngblood be appointed presiding officer.

Upon certificate of W. C. Arthur, Nick Jordan was exempted from Road duty in Sabine County, Texas.

The Court ordered that the First National Bank pay the semi-annual interest now due on the \$500,000.00 Sabine County Road Bond issue amounting to \$13,750.00 which became due and payable July 1st. 1918 and it is the further order of the Court that the County pay to the said First National Bank of Hemphill, Texas, 5% interest on said sum of \$13,750.00 until said interest coupons are paid by Sabine County.

The Court ordered the Clerk to issue each officer his per diem.

There being no further business the Court adjourned.
