

Hon. Commissioners court met in regular session on Aug. 9, 1920.
With the following members present:

The court was opened by proclamation of the Sheriff.

The court ordered that J. S. Kelly be exempt temporarily from road duty on account of physical condition as certified to by Dr. W. T. Arnold.

Upon petition the court granted the following third class road beginning at E. A. Chambers Mill on the upper Tebo and Bronson road thence in south easterly direction to T.M.

401

Wrights place intersecting the Bronson and Tebo high-way.

M. T. Bell Commissioner Precinct No. 2, having turned in his resignation to County Judge, the same was accepted and the office of Commissioner Beat No. 2, Sabine Co., Texas, declared vacant and the County Judge appointed J. M. Ball as Commissioner for Beat No. 2 to serve the unexpired term.

S. P. McElroy J. P. Precinct # 2, having tendered his resignation to the Commissioners court and same being accepted by the court, the office was declared vacant.

W. W. McElroy was appointed by the court as J. P. of Precinct # 2, Sabine Co, Texas.

Upon his executing the statutory bond, The court having advertised for bids for wood for the court house the following bids were received:

T. R. Smith \$8.00 per cord

L. C. Whittlesey \$5.00 Per cord.

A. J. Thedford \$5.00 "

T. F. Cammack \$4.50 " It appearing that T. F. Cammack was the lowest bidder and the Court awarded the contract to T. F. Cammack.

The Court ordered that the County Judge ask for bids for having the County Books Audit ed. beginning Dec. 1916 including 1920.

The Court ordered that the County Judge advertise for bids for the painting of the court house and jail roofs.

The Court allowed J. C. Speights \$6.75 for board paid out for John Cook.

The County Treasurer Report for the quarter ending Aug. 9th, 1920 was approved by the Court.

The court ordered County Judge to Execute lease to State High way department for two F.W. D Federal trucks and ordered the clerk to issue warrants for \$678.50 to cover delivery charges and rent for one year on said trucks.

The court ordered that an extention of time of three months be allowed to Smith Bros. for construction of the Hemphill & Geneva highway from the date of the expiration of the time limit granted them in contract.

The court ordered that a extention of time of three months be allowed to Austin Bridge Bro. for construction of the Hemphill & Geneva Highway from the dat of the expiration of the time limit granted them in contract.

Accounts were allowed as per ledger.
