Court having been called together in special session at which was present the entire Court, as follows: W. C. Arnold County Judge, S. W. Bright County Clerk, J. A. Regen Commissioner Precinct 1, Jerry Bell Commissioner Precinct No. 2, S. H. Hall, Commissioner Precinct No. 3, A. T. Matthews Commissioners Precinct No. 4, G. W. Alford Sheriff. The Court was opened by Proclamation of the Sheriff G. W. Alford, Sheriff the following matter were had to-wit:

Said session being had at the instance of Citizens of various parts of the County praying the Court to order road bond elections for their districts, which are hereafter set out, said session also being for the purpose of transacting such other business as is fully set out below.

The Court ordered road bond election for District #2, for issue of Fifty Thousand Dollars said Election to be held April 16th, 1921, said Election to be held at Allens Old Mill & J. T. McCown appointed presiding officer.

Ordered that road bond election be granted in Dist. No. 1, for issue of Seventy Thousand Dollars said Election to be held on April 23rd, 1921 same to be held at Fairdale & Roy Rogers appointed Presiding officer ordered that road bond election be granted in Road Dist. #3 for issue of \$100,000.00 Election to be held on April 23rd, 1921 same to be held at Sexton & Geneva, R. W. Harris is appointed presiding officer at Geneva J. W. Clifton is hereby appointed presiding officer.

Ordered by the Court that the County Attorney is hereby authorized & directed to take the necessary steps to Collect the \$500.00 as premium due the County on sale of the \$500,000.00 Road Bond issue, same to take effect from its due date Dec. 31, 1920, & interest thereon from date at 10% per annum.

Ordered by the Court that the room IN N. E. corner of on first floor of Court house and the same is hereby designated & established as office of County Tax Collector.

It is ordered by the Court that the room is the Northeast corner of 3rd floor of Court house be and the same is hereby designated and established as office of County demonstration agent.

To the Honorable Commissioners Court of Sabine County, Texas:

We the undersigned being resident citizens within the hereinafter described territory situated in Sabine County, Texas, respectfully represent:

First. That we are resident property tax paying voters within said territory.

Second. That we desire your Honorable body to order an election to determine whether or not the bonds of said territory, to be known and designated as "Road District No. 1".

of Sabine County, Texas," shall be issued in the amount of SEVENTY THOUSAND DOLLARS bearing five and one half per cent rate of interest, and maturing at such times as may be fixed by the Commissioners Court, serially or otherwise, not to exceed thirty years from date thereof, for the purpose of constructing and maintaining and operating macadamized, graveled or paved roads and turn pikes, or in aid thereof; and whether or not a tax shall be levied upon the property of said proposed Road District, subject to taxation, for the purpose of paying the interest on said bonds and to provide a sinking fund for the redemption thereof at maturity.

Third. That the territory which we pray your Honorable Body to designate as "Road District No. 1, of Sabine County, Texas," is accurately described by metes and bounds, to-wit:

: Beginning at the southwest corner of Sabine County, same, being the Northeast corner of Newton County, Texas, at a point on the west bank of Sabine River. Thence westerly with the line between Sabine and Newton Counties to a point where said line crosses the west boundary line of the M. W. Anthony Pre-emption survey. Thence North 23° 25' west with M. W. Anthony's west line to the Northwest corner of said survey on the South line of the Theo Koester survey, No. 6. Thence west 63 east to the South east corner of said Koester survey. Thence North 27 west with the east line of said Koester survey No. 6, and the east line of the G. H. & S. A. R. R. Co. survey, No. 6, same being the west lines of the C. L. Love and S. L. Bainwood surveys, to the S. boundary line of the Aurelia Russell League. Thence S. 63 W. with the South boundary line of said Aurelia Russell League to its Southwest corner. Thence N. 27 west with the west lines of said Aurelia Russell League and the A. W. Canfield League to the Northwest corner of said A. W. Canfield League. Thence South 63 west with the S. boundary line of the Henry Canfield League to its S.W. corner. Thence North 27 west with the west line of said Henry Canfield League to its North west corner. Thence North 63 East with the North line of said Henry Canfield League to the Southwest corner of the Robert Russell 1/4 League. Thence North 27 west with the west line of said Robert Russell 1/4 League 728 vrs. to the Northwest corner of a 239-1/2 acre sub-division of said Robert Russell survey. Thence N. 62-1/2 E. with the North line of said 239-1/2 acre sub-division to Six Mile creek. Thence down the Six mile creek in a south easterly direction with the meanders of said Creek to the S. W. corner of the A. C. Bell Pre-emption to its N. E. corner. Thence N. 24 west with the east line of the A. C. Bell Pre-emption to its N. E. corner. Thence N. 66 E. with the South line of the W. G. Edgar Pre-emption to the S. E. corner of said W. G. Edgar Pre-emption. Thence N. 24 west with the east line of the W. G. Edgar Pre-emption to its N. E. corner on the west line of the John S. Chiveral survey. Thence N. 25 west with the west boundary line of the John S. Chiveral survey to its N. W. corner on the South boundary line of the G. L. Bourland League. Thence N. 64 East with the N. line of the John S. Chiveral survey and the S. line of the G. L. Bourland league to the Housen Bayou. Thence down the Housen Bayou with its meanders to the mouth of Sulphur Slough. Thence up Sulphur Slough in a southerly direction to where said Slough crosses the N. line of the E. M. Carlton 640 acre survey. Thence N. 67-1/2 E. with the N. line of the E. M. Carlton 640 acre survey to its N. E. corner. Thence South 25 East with said E. M. Carltons East boundary line to the North line of the Henry Canfield League. Thence 67-1/2 E. with the N. line of the Henry Canfield League to its N. E. corner on the west bank of Sabine River. Thence down the Sabine River with its meanderings to the place of beginning, at the southeast corner of Sabine County.

Fourth. That the above described territory is situated wholly within Sabine County, Texas, and does not over lap or embrace any part of a political sub-division or defined Road District that has heretofore been established and issued road bonds which are

now outstanding and unpaid.
