Thomás and 34 other persons praying that bonds be issued by "Road District No. 6, of Sabine county, Texas, in the sum of \$45,000.00 bearing five and one half per cent rate of interest, maturing at such times as may be fixed by the commissioners court, serially or otherwise, not to exceed thirty years from date thereof for the purpose of constructing, maintaining and operating macadamized, graveled or paved roads and turnpikes, or in aid thereof, and whether or not a tax shall be levied upon the property of said road District No. 6, of Sabine County, Texas, subject to taxation, for the purpose of paying the interest on said bonds and to provide a Sinking fund for the redemption thereof at maturity; and,

It appearing to the court that said petition is signed by a majority of the resident property taxpaying voters of said road district No. 6, of Sabine county, Texas; and,

It further appearing that the amount of bonds to be issued will nit exceed one fourth of the assessed valuation of the real property of said Road District No. 6, of Sabine County Texas; and,

It further appearing that said Road District No. 6, of Sabine county. Texas, has been duly established by an order of the commissioners court of Sabine county, dated the 11th day of April A. D. 1921, of record in Book "L" pages \_\_\_\_\_, of the minutes of said court, and the boundaries thereof are herein described as described and defined in the order of the commissioners court establishing such district, as follows, to-wit:

Beginning in said Sabine county, Texas, at a point on the Pologocho creek where said creek crosses the east boundary line of the Moses Hill survey. Thence S 9 W with Moses Hill cast boundary line to the S. W. corner of the A. L. Frazier survey.

Thence down said Pologocho Bayou with its meandersings to the place of beginning, and being the same description of said territory as given in said petition; and It further appearing that said district does not embrace any part of a political subdivision or defined road district that has been heretofore established and has issued bonds which are now outstanding and unpaid. r

It is therefore considered and ordered by the court that an election be held in said road district No. 6, of Sabine county, Texas, on the 14th day of May A. D. 1921 which is not less than thirty days from the date of this order, to determine whether or not the bonds of said road district No. 6, of Sabine county, Texas, shall be issued in the amount of \$45,000.00, bearing five and one half per cent rate of interest, and maturing at such times as may be fixed by the commissioners court, serially or otherwise, not to exceed thirty years from the date thereof, and whether or not a tax shall be levied upon the property of said Road District No. 6, Sabine county, Texas, subject to taxation for the purpose of paying the interest on said bonds and to provide a sinking fund for the redemption thereof at maturity.

The said election shall be held under the provisions of Article 627 to 641 inclusive, of Chapter 2, Title 18, Revised Statutes 1911, as amended by Section 1, Chapter 203, Acts of 1917, Regular session. 1× 1 1

All persons who are legally qualified voters of this State and of this county and who are resident property taxpayers in Road District No. 6, of Sabine county, Texas, shall no entitled to vote at said election, and all voters desiring to support the proposition to issue the bonds shall have written or printed on their ballots the words: . . .

"For the issuance of bonds and the levying of the tax in payment thereof."

And those opposed shall have written or printed on their ballots the words: Against the issuance of bonds and the levying of the tax in payment thereof."

The manner of holding said election shall be governed by the general laws of the State of Texas, regulating general elections, when not in conflict with the provisions of the Statutes hereinabove referred to. . .

Notice of said election shall be given by publication of a copy of this order in the Sabine county Reporter a newspaper published in the county of Sabine State of Texas, for four successive weeks before the date of said election and in addition thereto, there shall . be posted other copies of this order at three public places in road District No. 6, of Sabine County, Texas, for three weeks prior to said election.

The county Judge is hereby directed to cause said notices to be published and posted, as hereinabove directed, and further orders are reserved until the returns of said election . are made by the duly authorized election officers and received by this court.

First. That we are resident property tax paying voters within said territory. Second. That we disire your Honorable body to order an election to determine whether or not the bonds of said territory, to be known and designated as "Road District No. 8, of Sabine county, Texas, shall be issued in the amount of \$2000.00 bearing five and one half per cent rate of interest, and maturing at such times as may be fixed by the commissioners court, serially or otherwise, not to exceed thirty years from date thereof, for the purpose of constructing, maintaining and operating macadamized, graveled or paved roads and turnpikes or in aid thereof; and whether or not a tax shall be levied upon the property of said proposed road district, subject to taxation for the purpose of paying the interest on said bonds and to provide a sinking fund for the redemption thereof at maturity.

Third. That the territory which we pray your Honorable body to designate as "Road District number 8, of Sabine County Texas," is accurately described by metes and bounds, towit:
