

April 20th, 1921.

The Commissioners court met in special session for the purpose of canvassing the returns of certain Elections hereinafter set out and to transact such other business as may come before it, with the following members present and presiding:-

W. C. Arnold County Judge

J. A. Ragan Commissioner Precinct No. 1.

W. M. Ball Commissioner Precinct No. 2.

S. H. Hall Commissioner Precinct No. 3.

A. T. Mathews Commissioner Precinct No. 4.

G. W. Alford Sheriff

S. W. Bright County Clerk.

The court was opened by proclamation of the Sheriff.

On this day came on to be considered the returns of an election held on the 16th day of April 1921 in Plainview Common School District No. 31 of Sabine county, upon the question of issuing \$1500.00 bonds for equipping a modern school building for said district running 20 years, with option of redemption after 10 years and bearing 5% interest, and levying a tax on all taxable property of said District sufficient to pay the current interest on said bonds and provide a sinking fund sufficient to pay the principal at maturity and it appearing that said election was in all respects legally held, and that said returns were duly legally made and that there were cast at said election 21 votes of which number there were cast for the bonds 18 votes, against the bonds 3 votes.

And it appearing to the court from said returns that a majority of the qualified property tax paying voters of said District voting at said election voted in favor of issuing said bonds and for said tax, the court does hereby declare the said tax to have carried in said District, and the proposition for the issuance of said bonds to have been adopted, and

that this court is authorized to issue said bonds and to levy and have assessed and collected said tax.

At a meeting of the Commissioners Court of the county of Sabine County, Texas held on the 20th day of April 1921 came on to be considered the returns of an election held on the 16th day of April 1921 to determine whether or not the bonds of said road district No. 2 of Sabine county, Texas should be issued to the amount of \$50,000.00 bearing interest at the rate of 5% per annum payable 30 years from date for the purpose of constructing, maintaining and operating macadamized, graveled or paved roads and turnpikes or in aid thereof and whether or not a tax shall be annually levied, assessed and collected in said road district No. 2 sufficient to pay the current interest on said bonds and to provide the required sinking fund to redeem them at maturity and it appearing that said election in all respects was lawfully held and said returns duly and legally made and that there were cast at said election 24 votes of which 20 votes are cast "For the issuance of bonds and levying of the tax in payment therefor" and 4 votes were cast "Against the issuance of Bonds and levying of the tax in payment therefor".

It is therefore ordered and declared that the proposition to issue said bonds and levy said tax was sustained by a two-thirds majority of the qualified property tax payers voting at said election and that the commissioners court of said county is authorized to issue said bonds and to levy and have assessed and collected said tax.

Ordered by the court that Tom Ford and S. Lee Convicts now working out their fines on the streets and on which here is a balance due of \$37.00, be discharged conditioned on their removing the forms and otherwise clearing and cleaning out the culverts on the Hemphill town square same to be approved by W. C. Arnold and that Judge Adams concurs in this to the extent that on said Arnold's O. K. of the work he will draw draft on Smith Bros. for the \$100.00 payable to County Judge of Sabine County heretofore held back pending the completion of said work.

Ordered by the Court that the Tucker bridge built by R. H. Minton on Pologoch Creek be and the same is hereby accepted and that his bid of \$595.00 for same be paid.

It is ordered that Court stand adjourned over until next Monday April 25th, 1921.
