COUNTY OF SABINE On this 10th day of Spptember, 1923, the Commissioners court of Sabine County, Texas, was convened in regular session at the september regular term thereof, the County Judge and all the Commissioners and the County Clerk being present, when among other business transacted, the following order was passed by a vote of four votes for its passage to no votes against its passage, to wit;

It is ordered by the court that the tax levying clause of the order of this court providing for the issuance of Five Thousand (\$5000.00) Dollars road and Bridge Funding Warrants passed by this court on the 9th day of April 1923, which is of record in Volume M pages 34 et seq. of the Minutes of the Commissioners court of Sabine county, Texas, be and the same is hereby amended nunc protunc, as of said date, April 9th 1923, to read as follows:

That to create said fund for the payment of the principal and interest of said warrants at maturity, a tax of 1-1 cents on each\$100 valuation of taxable property in said. Sabine County, out of the constitutional fifteen cents road and bridge tax, shall be annually, levied assessed and collected, or so much thereof as shall be necessary until all of said warrants and the interest thereon have been fully paid, and said tax of 1-1 cents is here now levied for the year 1923; it is further ordered that should said tax of 11 cents be insufficient to pay the whole of the principal and interest maturing in any one year to and inclusive of the final maturities of said warrants, then the Commissioners court of said county shall compute a and ascertain what rate of tax based upon the latest approved tax roll of said County, shall be necessary and sufficient to fully raise and produce the amount of principal and interest matured ing in said year and the rate of tax so found necessary shall be levied assessed, and collected for said year at the time other county taxes are levied assessed and collected and the proceeds thereof shall be placed in said special fund above named, and the Trasurer shall not honor any warrant or order upon said fund for any other purpose.

It is further ordered by the court that the warrant ordered hereinbefore referred to as thus amended is hereby confirmed ratified, and re enacted as fully and completely as if it were here set out is full.
