

The Hon. Commissioners Court, convened in regular Session on this the 14th day of January 1924. With all court present as following to-wit: W.H. Davidson, County Judge, J.H. Emer, County Clerk, J.A. Ragan, Commissioner Precinct #1, S.H. Hall, Commissioner Pre. # 3, A.F. Vickers Com. Pre. # 4. The court was opened by proclamation by the Sheriff.

1st, The following together with other to-wit: The court allowed J.W. Arnold, Geo. Oliver and Albert Carter, the sum of \$10.00 each as County Aid. 2nd, The County officers salary's were allowed by the Com. Court. 3rd, A.F. Vickers, made Sec. by Ragan to award the building of the Sec. B. of Highway No. 8. to George & Kerr. the Court voted aye. 4th, It is ordered by the court that W.E. Cardray's property for Taxes for the 1923, which is as the unrendered roll be reduced back to \$5.00 per acre.

The Commissioners Court in regular session February 11th, A.D. 1924, with the following members present: W.H. Davidson, County Judge, Presiding, J.A. Ragan Com. Pre. No. 1, J.M. Ball Com. Pre. No. 2, S.H. Hall, Com. Pre. No. 3, A.F. Vickers Com. Pre. No. 4, E.W. Nations, Sheriff and J.H. Emer County Clerk.

The Court was opened by proclamation of the sheriff. The following petition for a Stock Law election was presented to the court and was granted and the date of the election

set to be held on the 15th day of March A.D. 1924, at Milan, Texas, within said subdivision of Sabine County, Texas, and A.B. Russell appointed presiding judge of said election, and W.M. Davidson and Pole Mason as managers of said election to hold the same in accordance with the law relative to general elections in so far as the same are applicable.

THE STATE OF TEXAS: TO THE HONORABLE COMMISSIONER'S COURT OF
COUNTY OF SABINE: SABINE COUNTY, TEXAS:

The undersigned 22 Freeholders of the hereinafter described territory of Sabine County, Texas, desiring the commissioners court of such county to order an election to be held in such territory, as a subdivision of such county for the purpose of enabling the freeholders thereof to determine whether hogs, sheep, and goats shall be permitted to run at large therein, and desiring that such classes of animals shall not run at large therein, hereby petition said court to designate the following described territory within such county as a subdivision wherein and wherefore such election may be ordered and held to-wit:

Beginning in Sabine county, Texas, at the most easterly corner of the M.D. White survey on the N. Bank of Polo Gocho creek same being one of the corners of the Moses Hill League.

Thence W 810 yrs. to the S.W. corner of said Moses Hill League. Thence N. with the W. line of said Moses Hill League to its N.W. corner.

Thence E with the N. line of said Moses Hill League about 2587 yrs. to the most northerly N.E. corner of the said Moses Hill League. Thence S. 65 E with the N.E. line of the said Moses Hill League, 500 yrs. to the S.E. corner of the Major Survey. Thence N with the E. line of said Major Smith Survey 917 yrs. to its N.E. corner. Thence N 56 W 6000 yrs. to the S.E. corner of 118 1/2 acres in the Issac Powell League formerly owned by Mathew Cartwright, same as the N.E. corner of the W.W. Lawson tract on the E. line of said Issac Powell League. Thence W to the Milam and Sexton or Milam and Shelbyville road. Thence with said road to the leading to Sneed's Old Mill. This point being on the eastern boundary line of the subdivision described in Vol. 11, Page 117, Minutes of the commissioner's court for Sabine county, Texas, dated Sept. 8, 1913, and known as the Geneva Stock Law Sub division in Sabine county, Texas.

Thence westerly and southerly with the southerly and eastern boundaries of said subdivision now as said Geneva Stock Law subdivision now exist, to the Polo Gocho creek. Thence down said creek with its meanders to place of beginning. This the 9th day of February A.D. 1924.
