being present and passed the following order.

That whereas it has been made known to the Court that 975 acres of the A. W. Genfield League of land was omitted from the tax rolls of Sabine County for the year 1922, and that said land is owned by the heirs of John Mackenney. It is ordered that a list of said land be made in triplicate and referred to the Tax Assessor who is hereby ordered to make an assessment of said property for the taxes for the year 1922 at a valuation of \$10.00 per acre, and when completed to submit the same to the Commissioners County. And when approved to cause the taxes to be computed and extended at the rate fixed by the Court for the year 1922, and in addition thereto to add a penalty equal in amount to what would be six per cent interest to the date of making said list from the date such properties would have been delinquent had same been properly rendered by the owners thereof for the year 1922; and said Assessor shall furnish one list to the Tax Collector, one to the State Comptroller and file one copy with the County Clerk.

That, whereas, it has been made known to the Court that 1285 acres of Abstract No. 3, of the A. W. Canfield survey, was assessed to unknown owners on the unrendered tax rolls of Sabine County for the year 1923, at a valuation of \$20.00 per acre. And it being further made known to the Court that such valuation is excessive and unreasonable, and that \$10.00 per acre is a fair and reasonable valuation on said land. It is therefore ordered by the Court that the valuation on said 1285 acres be and is hereby reduced to \$10.00 per acre and the Tax Collector of this County is hereby ordered and instructed to accept payment on said land of the taxes due for said year at a valuation of \$10.00 per acres, on the whole or any part thereof.
