The State of Texas, County of Sabine. On this the 18 day of August 1924, the County Commissioners Court convened in regular session at the regular meeting place thereof in the Court house at Hemphill, Texas the following members of said court to wit:

W. H. Davidson, County Judge  
J. M. Ball, Commissioner Precinct No. 2.  
S. H. Hall, Commissioner Precinct No. 3.  
A. F. Vickers, Commissioner Precinct No. 4.  
being present, and passed the following orders:  
(1) That 7 cents of the 1924, 25 cents General County levy be and is hereby set aside to pay interest on the warrants and as a sinking fund to redeem Gen. Funding Warrants Class No. 1, of the sum of \$21000.00. (2) And that 5½ cents of the 1924, 25 cents General County levy be and is hereby set aside to pay interest on the warrants and as a Sinking fund to redeem Gen. Funding Warrants Class No. 2, of the sum of \$55000.00.  
(3) That 6 cents of the 1924, 15 cents Road & Bridge levy be and is hereby set aside to pay interest on the Warrants and as a Sinking fund to redeem Road & Bridge Warrants Class No. 1, of the Sum of \$6000.00. (4) That 7 cents of the 1924, 15 cents Road & Bridge levy be and is hereby set aside to pay interest on the Warrents and as a Sinking Fund to redeem Road & Bridge Warrants Class No. 2, of the sum of \$16,000.00. (5) And that 2 cents of the 1924, 15 cents Road & Bridge levy be and is hereby set aside to pay interest on the Warrants and as a Sinking fund to redeem Road & Bridge Warrants Class No. 3, of the sum of \$5,000.00. (6) That a division of the P. I. Fund be had and the same was divided as follows to-wit:

J. A. Ragan, Commissioners Prec. No. 1, \$689.93  
J. M. Ball, Commissioners Prec. No. 2, \$1707.10  
S. H. Hall, Commissioners Prec. No. 3, \$1375.75  
A. F. Vickers, Commissioners Prec. No. 4, \$1722.75  
(7) That Jno. Harper, County Treasurer, open up a P. I. Fund Account with each Commissioners and credit their accounts as follows: J. A. Ragan \$689.93, J. M. Ball \$1707.10, S. H. Hall \$1375.75, and A. F. Vickers \$1722.75, and that the P. I. Fund account be charged up with the same amounts as credited to each Commissioners.

(8) That the petition presented to the court signed by B. H. White et al be granted the petition reading as follows:

The County Officers.

(1) On motion by J. A. Ragan second by J. M. Ball the Bonds for road District No. 12 will be sold.

All the Court voted (nay) to sell said bonds.

(2) Ordered by the Court to allow J. W. Arnold, Geo. Oliver, Albert Carter, \$10.00 each. Amanda Grant and John L. Watson \$5.00 each as County aid.

(3) A motion by A. F. Vickers second by S. H. Hall to rescind the order of the court to sell the Bonds of Road District No. 12, A. F. Vickers and S. H. Hall voted (nay) J. A. Ragan and J. M. Ball voted (no).

The vote being tied, the Judge voted of the tie by voting to rescind the act of the court to sell said bonds.

(4) The Application of C. M. Bennett to be released as Public weighes for Pre. #1, was accepted by the Court.

(5) The application of V. F. Williams and G. H. Davidson for the appointment of Public weighes Pre. # 1, was called and the Court appointed G. H. Davidson as public wieghes for pre. # 1.

(6) The following accounts was refused by the Court. \$5.00 damage to cotton by gravel pit, for Jack Earl.

Account of Underwood Typewriter Co. for \$80.00 for Typewriter for Clerk's Office.

Account of N. W. Ener for Typewriter to the amount \$115.00 for Tax Collector's Office.

(7) It is ordered by the Court that all parties conducting a Ferry Boat on the Sabine River must secure License for said ferry. License as following:

Chambers Ferry, \$3.50

Carter's Ferry, \$3.50

Sabine Town Ferry, \$6.50

Robertson Ferry, \$2.50

Mitchell Ferry, \$2.50

The Court sets the following prices to be charged by said Ferrymans, copy of same to be posted up at the Ferry house as boat. Automobiles 75 cents, wagons 75 cents Horseback 25 cent. Cattle from 40 head up, 5 cents a head, also other stock, single cows and horses 25 cents. Truck over two tons \$1.50, other trucks same as cars.

This price includes one way.

(8) The Bond of G. H. Davidson was presented and approved, as Public weighes for pre. # 1.

Court adjourned until its next regular meeting date.

The condition of the above obligation is such, that whereas, the above bounden G. H. Davidson, was on the 8th day of September, A.D., 1924, duly appointed to the office of Public Weigher in and for Justice Precinct No. 1, in the County of Sabine State of Texas.

Now therefore, if the said G. H. Davidson shall faithfully and impartially perform and discharge all of the duties of his office required of him by law as Public Weigher aforesaid, then this obligation shall be null and void, otherwise to remain in full force and effect.
