Ordered by the Court the petition of W. L. Anderson et al., being qualified Tax payi voters of Road Bond District No. 12 of Sabine County Texas, requesting that the court not offer said bonds of said road District No. 12 of Sabine County, Texas, be and is hereby granted.

Be it ordered by the Commissioners Court of Sabine County, Texas, that there is hereby levied for the year 1924; on all taxable property in Road Bond District No. 4 & 8 for the 1st day of January of the current year a tax of and at the rate of \$1.80

\$2.20, \$2.00 and \$0.60 respectfully (Instead the rates legied at the February term 1924 in said districts) on the \$100.00 valuation of taxable property in said districts estimated in lawful currency of the U.S. of America to provide a sinking fund to pay all bonds and interest that mature in said district for current year. Be it ordered by the Commissioners Court of Sabine County, Texas, that there is hereby levied for the year 1924, on all taxable property insaid Sabine County, Texas, on the 1st day of January of the current year a tax of and at the rate of 70 cents on the \$100.00 valuation to provide a Sinking fund to pay all bonds and interest that mature for the current year.

Be it ordered by the commissioners Court of Sabine County, Texas, that there is hereby levied for the year 1924 on all taxable property in the following named common School District, fiz; 5,8,15,25,26,27,32,54,35,56,& 37, on the 1st day of January of the current year the following Taxes, an advalorum tax of and at the rate of 25 cents on the \$100.00 valuation of taxable property in said district estimated in lawful currency of the United State of America to supplement the State School fund appointed to said district for support and maintenance of the Public Free School therein these levy has been made in addition to the 50 cent levy made at regular term of February term of Commissioners Court 1924. And also a levy of 25 cent in common School Districts No. 16, 17 & 20 on the \$100.00 valuation of taxable property for the same purpose as stated in District # 3, 8, 15, 25, 26, 27, 32, 34, 35, 36, & 37, on the list day of January of the current year this levy has been made in addition to the 20 cents in District # 16, 35 cents in District # 17 and 28 cents in District # 20 made at February term 1924.
