

COUNTY OF SABINE. On this the 28 day of September, 1925, the Commissioners Court of Sabine County, Texas, being in Special session, at a Call term of said Court, the following members thereof being presents: W. H. Davidson, County Judge; C. W. Fuller, Commissioner Precinct No. 1; W. J. McDaniel, Commissioner Precinct No. 2; J. P. Roely, Commissioner Precinct No. 3; K. C. Travis, Commissioner Precinct No. 4, the following proceedings among others were had to-wit:

WHEREAS, on the 10th day of August, 1925, the Commissioners Court of Sabine County, passed an order authorizing the issuance of ELEVEN THOUSAND DOLLARS (\$11,000.00) SABINE COUNTY JAIL IMPROVEMENT WARRANTS to evidence the indebtedness due the Southern Steel Company for the construction of Jail Improvements according to contract between said Company and Sabine County, said Warrants to be delivered to said contractor on estimates, as the work progresses, which order is recorded in Book M, page 315, et seq., of the Minutes of said Court, and

WHEREAS, said Contractor has presented its estimates under said Contract which is in words and figures as follows:

TO THE HONORABLE COMMISSIONERS COURT OF SABINE COUNTY, TEXAS:

The following is an estimate of work completed under contract between Sabine County and the Southern Steel Company, dated August, 10th, 1925, respectively: When the call work is delivered on the building site ----- \$5,000.00

and, WHEREAS, the material furnished and the work performed under said contract as covered by said Estimate, has been inspected by this Court and accepted as being in accordance with said contract and the specifications adopted by this Court:

that said Estimate in the sum of \$1,500.00 be and the same is hereby approved and allowed; that in accordance with said contract, there shall be executed and delivered to said Contractor, SABINE COUNTY JAIL IMPROVEMENT WARRANTS for the full amount of said estimate, being warrants numbers 15 to 17 inclusive, aggregating \$1,500.00 of an issue of 22 warrants, of the denomination of \$500.00, each, aggregating \$11,000.00 dated September, 1st, 1925, bearing interest at the rate of 6% per annum, authorized to be issued as the total contract price in warrants to be paid said Contractor, under said contract; and that said County of Sabine has received full value and consideration for said warrants, 15 to 17 inclusive.
