D. 1922, and recorded in Minutes of the Commissioners' Court in Vol. L. Page 612.

W. G. Patterson's name having been placed before the Court as a candidate for the office of Public Weigher, Justice Peace Precinct No. 1, Sabine County, Texas, on motion of R. C. Travis seconded by C. W. Fuller the question was put thus, "Those members of the Court favoring the appointment of W. G. Patterson to the office of Public Weigher, Justice Peace Precinct No. 1, Sabine County, Texas, let your wish be known by saying "Aye", the Court voted unanimously for the appointment.

Therefore W. G. Patterson has this day been duly and legally appointed to the office of public Weigher, Justice Peace Precinct No. 1, Sabine County, Texas, to serve until January 1st, A. D. 1927, and until his successor is duly and legally elected and qualified. THE STATE OF TEXAS:

That the Ferryman at Pendleton, Texas, on the Sabine river, operate the Ferry "free" from sunup till sundown and from sundown till sunup charge the following prices:

Be it ordered by the Commissioners' court that the rate of tax in common school Districts No. 11 & 14 be raised from 50¢ to 75¢ on the \$100, valuation of all property in said districts on January 1st, 1926, and that the rate of tax in common school Districts No. 17 & 30 be increased; or raised, from 75¢ to\$100.00 on the one-hundred dollars valuation of all property in said districts on January 1st, 1926, These orders conform to the increase of tax by a vote of the equalified property tax paying voters in said districts since the tax levies made in May 1926.

Be it ordered by the Commissioners! Court that the permanent improvement rate of tax be reduced from 25¢ to 20¢ on the \$100.00 valuation of all taxable property in the county on the 1st day of January 1926.

Be it ordered by the court that the county Clerk issue against the General Fund and in favor of C. M. Bennettt, Max Assessor, a Warrant for \$250.00 in part payment 1926 assessed rolls.

Be it ordered by the Commissioners County that the Delinquent tax list or rolls for Sabine County be published in the Sabine County Reporter, a weekly newspaper, each week for three consecutive weeks.
