The Honorable Commissioner's Court met in regular session March 14th, 1927, all members thereof being present, to-wit

and transacted the following business:

Besides allowing regular accounts the following orders were passed:

E. H. White was appointed Constable Precinct #8.

Jury Room constructed by C. H. Cordray was received.

Toilet constructed by L. A. Fuller was received.

Contract for construction of an addition to the office of the County Attorney was awarded to C. H. Cordray, the contract price being \$95.00.

Contract for office room on Second floor was awarded to C. H. Cordray, contract price being \$52.00.

During the absence of the County Judge while holding Juvenile Court, R. C. Travis was appointed Judge Proteim, and during such incumbency the following orders were passed:

That Jas. G. Barker, County Attorney proceed with all due dispatch to collect delinquent taxes. That Marion Isom and John H. Latham be appointed road over-seers for the balance of road year ending May 1st, 1927, that \$5.00 per month be allowed to night-watchman, that Mrs. Lakey be allowed \$5.00 County Aid, that Mrs. Gates be allowed \$5.00 for condemned animal.

It is further ordered by the Court by unanimous vote of all the Commissioners that the road leading from the Hemphill and Milam Highway about one shalf mile South of the town of Milam by way of the William Gellately home, Frank Elliott's, Grady Finley's, Roy Buckley's, Hosea Burkhalter's, E. W. Dorsey's, Shelton Diokerson's, Mr. Lee Buckley's, W.H.Curl's, Jake Buckley's, Ira McLemore's, the old Henry White place, Mrs. Ruth McLemore's, J.J.Mc-Lemore's, Ben Cunningham's and Wiley Griffin's place to an intersection with the public road leading from Hemphill to Tebo, be change from a third class to a second class road with width of thirty feet.

It further appearing to the Court that the people living on said road have petitioned a change from a third to a second class and have executed transfer of right-of-way thereto with the exception of Mrs. Lee Buckley and her children, Roy Buckley, Pearl Conn and Ivey Buckley.

It is therefore ordered by the Court thatR. W. Harris, Andrew Jordan, Sam Low, W.H. Crowell and J. O. Smith be and are hereby appointed to lay out, survey and describe said-road of the width of thirty feet to the greatest adventage to the public so that the same can be traced with certainty and to assess the damages to the lands of Mrs. Lee Buckley, Roy Buckley, Pearl Conn and Ivey Buckley, which will be occasioned by the widening of said road through their premises from twenty to thirty feet in width and make their report to this court as the law directs.
