The bond of F. S. Morrison, as Justice of the Peace, and Ex-Officio Notary Public,
was approved.

Bids for the operation of Pendleton Ferry for the year 1928, were received. The bids
submitted were as follows: J. J. Pate, \$85.00, J. V. Guin, \$70.00, S. E. Smith, \$64.95,
C. H. Coleson, \$65.00, W. F. Smith, \$60.00, Levi Crowell, \$69.95, R. C. McGowen, \$69.95,
W. C. Gaskin, \$64.74. The bid of W. C. Gaskin was accepted, and his bond of \$1000.00
with J. H. Ener and A. G. Pratt, as sureties, were approved.

It was ordered by the court that the land value of George Bowie, be reduced from \$6.00
to \$4.85, per acre.

That the 11 acres of E. E. McLemore, abstract No. 8, Wm. Clark, be reduced from
\$9.00 to \$5.00 per acre.

That the court approve the account of Adams Grader Co. for one Adams Leading Wheel
Grader, No. 8, at the price of \$1030.00 less credit of 3% quantity discount, leaving a bal-
ance of \$999.10, said amount being payable in 3 installments as follows: 4-15-28
\$333.04, 4-15-29, \$333.03, 4-15-30, \$333.03.

Ordered that the County Judge, together with the County Treasurer, be authorized to
borrow from First National Bank of Hemphill, Texas, \$25000.00 to pay County wide bonds and
interest coupons, issue of January 1st, 1918, which mature Jan. 1st, 1928, and payable at
Hanover National Bank, January 1st, 1928. Said money to remain on deposit at said bank for
10 days only.
