Thence with the said east north and west boundary lines of said school district to the place of beginning.

ORDER ESTABLISHING VOTING PRECINCT NO. 17.

Upon petition of B. F. Chambers, and 40 others, and believing it proper and to the best interest of all concerned, the

Commissioner's Court, on this the 23 day of January A. D. 1928, all members, thereof, to-wit: R. H. Dent, County Judge, E. J. McGowan, Commissioner Precinct No. 1, J. A. Hyden, Commissioner Precinct No. 2, J. D. Edgar, Commissioner Precinct No. 3, and R. C. Travis, Commissioner, Precinct No. 4, being present, pass the following orders:

The Commissioners' Court in regular session convened at its regular meeting place in the court house, does hereby declare the territory as described within the following metes and bounds, as election precinct No. 17, of Sabine County, Texas, with voting box at the school house in common school district No. 38, which is located within the metes and bounds of voting precinct No. 17 herein described.

Beginning at a point in Isla highway near the Barney Chambers place, at the corner of Patroon school district No. 38, and extending with said highway in front of Barney Chambers, to the old Carter's ferry road. Thence with said Carter's ferry old road to the Huffan bridge, on Patroon creek. Thence continuing with said old road to Greshaw bluff. Thence N. with Sabine river to the point of intersection with the east corner and boundary line of the said <sup>Patroon</sup> school district. Thence with the said east, north and west boundary lines of said School district to the place of beginning.
