

ORDER OF BOND ELECTION IN COMMON SCHOOL DISTRICT:

The State of Texas  
County of Sabine

Whereas, on the 10th day of October, A. D. 1928, a petition was presented, to me for an election to be held in Plainview Common School District No. 31, of this County, on the question of issuing bonds for the purposes of building and equipping an addition of wood to the present wood school building in Plainview Common School District No. 31, Sabine County, Texas, within said district, and authorizing a tax upon all taxable property within the said District sufficient to pay the current interest on said bonds and provide a sinking fund sufficient to pay the principal as the same becomes due; and

It appearing that said petition bears the requisite number of signatures of qualified property taxpaying voters of said District, and is in every respect in conformity with the laws; and

It further appearing that Sabine County contains a population of 12,299 according to the

last United States Census; and

It further appearing that said Plainview Common School District No. 31, has been heretofore properly established in accordance with Article 2817, Revised Statutes of Texas, 1911, as amended by Chapter 36, Regular Session of the 34th Legislature 1915, and

It further appearing that said District as so established, contains an area of 10.54 Square miles, and that no other district has been reduced in area below nine square miles by reason of the creation of this district, and

It further appearing that the geographical center of said District is not more than four miles from the farthest boundary line thereof and

It further appearing that said District does not embrace any territory that was taken from any other school district (either Common or Independent), that had an outstanding issue of bonds at the date of such inclusion in this district.

Now, therefore, I, R. H. Dent, in my official capacity as County Judge, of Sabine County Texas, do hereby order that an election be held on the 24th day of November, A. D. 1928, at the School house in said Plainview Common School District No. 31, of said County as re-established by order of the Co. Board of School Trustees, as passed on the 6 day of April, 1921, which order is of record in Record of School Districts, to determine whether or not a majority of the legally qualified resident property taxpaying voters of said district desire the issuance of bonds to the amount of \$1000, One Thousand Dollars, (\$1000.) Dollars, (to become due and payable 20 years after date, optional after 10 years, and bearing interest at the rate of 6 per centum per annum, interest payable annually, on the faith and credit of said Common School District, for the purpose of building and equipping an addition of wood to the present wood school building in Plainview Common School District No. 31, Sabine County, Texas, within said District, and to determine whether the Commissioner's Court of said County shall be authorized to levy, assess and collect annually while said bonds or any of them, are outstanding a tax upon all taxable property within said District sufficient to pay the current interest on said bonds and provide a sinking fund sufficient to pay the principal as the same becomes due.

A. H. McGown, is hereby appointed presiding officer for the said election and he shall select two Judges and two Clerks, to assist him in holding the same and he shall, within five days after said election has been held, make due return thereof to the Commissioner's Court of this County as is required by law, for holding a General Election.

All persons who are legally qualified voters of this State and of this County and who are resident property tax payers in said District, shall be entitled to vote at said election and all votes desiring to support the proposition to issue the said bonds shall have written or printed on their ballots, the words: (For the issuance of Bonds and the levying of the Tax in Payment thereof.) and those opposed to the proposition to issue the said bonds shall have written or printed on their ballots, the words: (Against the issuance of Bonds and the levying of the tax in payment thereof.)

The Sheriff of this County shall give notice of said election by posting three notices thereof in three public places within the boundaries of said District for Three weeks prior to the date fixed for said election.
