Notice is hereby given that an election will be held on the
24th day of November, A. D. 1928, at Plainview School House.

in Plainview Common School District No. 31, of this County as established by order of the Board of County School Trustees, as passed on the 6 day of April 1921, which order is of record in Record of School Districts, to determine whether or not a majority of the legally qualified resident property taxpaying voters of said Plainview common school District #31, District desire the issuance of bonds to the amount of One Thousand, (\$1000.00) Dollars, numbered consecutively from 1 to 2, both inclusive, of the denomination of 500.00 each aggregating \$1000.00 and bearing interest at the rate of 6% per centum per annum, interest payable annually, the 10th day of April of each year, on the faith and credit of said common school District for the purpose of Building and equipping an addition of wood to the present wood school building in Plainview Common School District #31, Sabine County, Texas, within said District and to determine whether the Commissioners' Court of said County shall be authorized to levy, assess and collect annually while said bonds, or any of the, are outstanding, a tax upon all taxable property within said District sufficient to pay the current interest of said bonds and provide a sinking fund sufficient to pay the principal at maturity.

A. H. McGown, has been appointed Presiding officer for said election and he shall select two Judge, and two Clerks, to assist him in holding the same and he shall, within five days after said election has been held, make due return thereof, to the Commissioners' court of this County as is required by law for holding a general election.

All persons who are legally qualified voters of this State and of this County and who are resident property taxpayers in said District shall be entitled to vote at said election and all voters desiring to support the proposition to issue the said bonds shall have written or printed on their ballots, the words: (For the issuance of bonds and the levying of the tax in payment thereof.) (and those opposed to the proposition to issue the said bonds shall have written or printed on their ballots, the words: (Against the issuance of bonds and the levying of the tax in payment thereof.)

Said election was ordered by the County Judge of this County by order made on the 29 day of October, A. D. 1928, and this notice is given in pursuance of said order.
