

ORDER AUTHORIZING THE ISSUANCE OF BONDS IN COMMON SCHOOL DISTRICT:

In the Commissioner's Court of Sabine County,

On this, the 10 day of December, A. D. 1928, the commissioner's Court of Sabine County, Texas, convened in regular session, all the members thereof, to-wit:

being present, and, among other proceedings, passed the following order:

Whereas, at an election held for the purpose on the 24 day of November, A. D. 1928, a majority of the legally qualified resident property taxpaying voters of Plainview Common School district No. 31, of this County, having at said election, voted in favor of the issuance of the bonds hereinafter described and in favor of the tax hereinafter levied.

Therefore be it ordered by the Commissioners' Court of Sabine County, Texas: that the bonds of said District to be called Plainview Common School District No. 31, schoolhouse Bonds, be issued on the faith and credit of said Plainview Common School District No. 31 of said County as reestablished by order of the County Board of School Trustees, as passed on the 6 day of April, 1921, which order is of record in Records of School Districts, for the purpose of Building and equipping an additional of wood to the present wood school building in Plainview Common School District No. 31, Sabine County, Texas.

2. That said bonds shall be numbered consecutively from 1 to 2 inclusive, shall be of the denomination of Five Hundred (\$500.00) Dollars, each, aggregating One Thousand (\$1000.00) Dollars.

iii. That said bonds shall be dated the 10 day of December, A. D. 1928, shall become due and payable annually April, 10th of April of each year, but bonds numbered 1 to 2 both inclusive, may be redeemed at the pleasure of said District at any time after 10 years from their date.

iv. That said bonds shall bear interest at the rate of 6 per centum per annum payable annually on the 10 day of April of each year.

We, the undersigned, qualified property taxpaying voters of Common School District No. 31, in Plainview, Sabine County, pray that an election be ordered to be held in said District to determine whether a majority of the legally qualified property taxpaying voters of said District desire the issuance of bonds, numbered consecutively from one to two, both inclusive, of the denomination of \$500.00, each aggregating \$1,000.00 ^{over for 20 yrs with of - 20%} to bear interest at the rate of ~~5%~~ 6% per cent per annum, payable annually, April, 10th, of each year, said bonds to be payable twenty years from their date Optional after ten years, on the faith and credit of said Common School District, to provide funds to be expended in payment of accounts legally contracted in Building and Equipping an addition of wood to the present wood school building in Plainview Common School District No. 31, Sabine County, Texas, and to determine whether the Commissioners' Court of said County shall be authorized to levy, assess and collect annually while said bonds, or any of them, are outstanding, a tax upon all taxable property within said district sufficient to pay the current interest on said bonds and provide a sinking fund sufficient to pay the principal at maturity.
