TO THE COMMISSIONERS COURT OF SABINE COUNTY, TEXAS:

GENTLEMEN:

We, the undersigned, would represent for the convenience of ourselves and the public generally that a public road of the second class should be established beginning at the home of Earnest McLemore and extending South with and along the boundary line of E. E. and Ira McLemore's land and continuing in the same direction to a point of intersection with highway No. 93, a short distance East of the place known as the Welch Place, a distance of approximately two miles. We therefore as property owners, living along and adjacent to this land respectively request that your honorable body establish this as a second class road which will be a direct connection of the Hemphill and Tebo road with the State Highway No. 93, from Hemphill to Bronson, and making an all weather route between these roads. We would further represent to the court that we will cooperate to secure free right-of-way and assist in opening the road.
