Sabine County, Texas, was convened in regular session; at the November regular term, thereof, the County Judge and all of the County Commissioners and the County, Clerk, Leing presents, when moons, other business transacted, the following order was passed by a wote of 4 votes for its passage to norvotes against its passage to wit: Whereas, there are certain County Permanent Improvement Sorip or warrants outstanding and unpaid which are a legal, charge against Sabine County, and this Court having had underconsideration, the advisability and necessity for extending the time of payment and issuing in lieu thereof, interest pearing time warrants; and it appearing to this court that in the issuance of warrants in lieu of which the warrants hereinafter described were lissued, evidencing the expenditure of two Thousand (\$2000.00) Dollars; or more, the contract furnishing the basis for such expenditure was first submitted to competitive bids, after prior notice by publication as required by law, except where any one of said Warrants represents the aggregate amount

of separate and independent contracts of purchase of materials and the performance of labor, such warrants being fasued to cover the aggregate total; and it further appearing to this count that in the issuance of each of the warrants hereinafter set forth evidencing the expend ture of less than Two Thousand (\$2000.00) Dollars, and more than Five Hundred (\$500.00) Dolcontract, furnishing the basis of said expenditure, was first submitted to competitive lars, the ids, and said contract was awarded upon competitive bids; in each instance, at a regular term the court, except in those instances where waid warrants represent expenditures for work

day; and And it further appearing to this court that it is necessary and advisable to issue funding warrants for the purpose of funding said outstanding scrip or warrants and issuing to the holders thereof interest bearing time payment warrants;

Therefore, be it ordered by the Commissioners' court of Pabine County, Texas,

That warrants to said County, to be denominated "Sabine County Permanent Improvement Funding Warmants" be issued under and by virtue of the Constitution and laws of the State of Texas, for the purpose of funding an equal amount of warrants of said County heretofore duly and legally issued for Permanent Improvement purposes and which are valid, subsisting and now outstanding obligations against said County, the claims for which were duly audited, approved and allowed, by the Commissioners! Court, prior to the issuance of said warrants, and which are to be surrendered and cancelled, and the permanent Improvement Funding Warrants hereby authorized issued to the holder or holders in lieu thereof, a list of which original outstanding warrants is as follows:

Said funding Warrants shall bear interest at the rate of 6% per annum, from date thereof until fully paid, payable April 10, 1931, and semi-annually thereafter on October, 10, and April, 10, each year, which interest shall be evidenced by coupons attached to each of said warrants.

The principal and interest of said warrants shall be payable upon presentation and surrrender of warrants or proper coupons at the Central Hanover Bank, and Trust Co. New York City, N. Y.

Said warmants shall be signed by the County Judge, attested by the County Clerk, and registered by the County Treasurer, and the seal of the Commissioners' court shall be impressed upon each of them,; the facisimile signatures of the County Judge and County Clerk, may be lithoggaphed or printed upon the interest coupons.

The form of said Warrants shall be substantially as follows: No.

SABINE COUNTY PERMANENT IMPROVEMENT FUNDING WARRANT:

The County of Sabine, in the State of Texas, hereby promises to pay to bearer on the loth day of April, 19 ___, at the Central Hanover Bank and Trust Co., New York, N. Y. the sum of Five Hundred Dollars, in lawful money of the United States of America, with interest thereon from date hereof, at the rate of 6% per annum, interest payable April, 10, 1931, and semi-annually thereafter on October 10, and April, 10; each year, upon presentation and surrender of procer poupons; and the Treasumer of said County is hereby authorized, ordered and directed to pay to bearer said principal sum; together with interest thereon, evidenced by coupons hereto annexed. In event the sum of money evidenced by this warrant, or any of the annexed coupons, is not paid at maturity, the same shall thereafter bear interest at the rate of 6% per annum, until fully paid; and in the event of such default and this warrant or any of the annexed coupons shall be placed in the hands of an attorney, or suit is instatuted thereon, then Sabine County, shall be obligated to pay to the holder or holders thereof, an additional ten per cent as attorneys fees.

This warrant is one of a series of eleven warrants, numbered from 1 to 11 inclusive, of the denomination of \$500.00 each, aggregating \$5,500.00 all of which warrants are issued for the purpose of funding an equal amount of warrants of Sabine County, duly and legally issued for Permanent Improvement expenses, and other expenses incident thereto; the claims, for which were duly audited and allowed by the Commissioners' Court, of said County prior to thei issuance; and for which said County received full value and consideration, and hereby acknowledges receipt of same; and which warrants were authorzed by orders duly and legally passed' prior to their issuance, made and entered upon the Minutesof the Commissioners' court of Sabine county; and the holder hereof, shall and will be subrogated to all the rights and privileges against said County had and possessed by the holders of said original warrants, in accordance with the Constitution and laws of the State of Texas, and in pursuance of an order passed by the Commissioners' Court of Sabine County, which order is recorded in the Ainutes of said court.

And it is hereby certified and recited that all acts, conditions and things required to be done precedent to and in the issuance of this warrant, have been properly done, happened and performed, in regular and due time, form and manner, as required by law, and that the total indebbedness of said county; including this warrant, does not exceed any constitutional or statutory limitation; and that provision has been made for the levying of taxes annually for the payment of principal and interest of this warrant, and all other warrants of this series; as they resectively mature. The date of this warrant, in conformity with the order above mentioned, is November 35, 1930; In testimony whereof, the Commissioners' Court of Sabine County, Texas, has caused the seal of said court to be hereto affixed and this warrant to be signed by the County judge, at tested by the county Cherk, and registered by the County Treasurer, as of the date last above written. County Treasurer. The form-of interest coupon shall be substantially as follows:

County Clerk. Lt is further ordered by the court that said original warments outstanding againsts aid County be, and the same are hereby in all things adjudicated and held and declared to be valid subststing, bing and unsatisfied obligations against said County, and the acts of the County officials in the issuance of said warrants are hereby in all things ratified and confirmed.

It is further ordered that a special fund, to be designated "Special Permanent Improvement funding warrant fund" be andethe same is hereby ordered and directed to ppen an account with said fund, to which fund shall be credited all taxes levied for the payment of primipal and interest of this series of warrants, as well as all moneys appropriated for said purpose, and no claim or warrant, other than warrants and coupons of the above series of warrants shall be paid out of said fund.

That to create said fund for the payment of the principal and interest of said warmants at maturity; a tax of three cents on each \$100.00 valuation of taxable property in said Sabine County, out of the constitutional twenty-five centes Permanent Improvement tax, shall be annually levied, assessed and collected, or so much thereof, as shall be necessary, until all of said warrants and the interest thereon, shall have been fully paid, and said tax of Three cents is here now levied for the year 1930, and for each succeeding year, or so much thereof, as may be necessary for said purpose, while said warrants or any of them, are outstanding; and it is further ordered that should said tax of three cents be insufficient to pay the whole of the principal and interest maturing in any one year to and inclusive of the final maturities of said warrants, then the Commissioners' court of said County shall compute and ascertain wha rate of tax, based upon the latest approved tax rolls of said county, shall be necessary and sufficient to fully raise and produce the amount or principal and interest maturing in said year, and the rate of tax so fond necessary shall be levied, assessed and collected for said year, at the time other county taxes are levied, assessed and collected, and the proceeds a thereof shall be placed in said special fund above named, and the Treasurer shall not honor any warrant or order upon said fund for any other pu pose
