#### ORDER OF THE COMMISSIONERS' COURT GRANTING LICENSE TO OPERATE A FERRY:

The State of Texas, } Know all men by these presents, that whereas, C. N. McCown, who has  
County of Sabine, } made satisfactory bid for contract to operate a ferry at Kendleton  
Crossing, on the Sabine River, in said County of Sabine, and has made his bond in the sum as  
required by law, for the operation of a ferry.

The said C. N. McCown, is therefore awarded a contract to operate the aforesaid Ferry for  
the term of two years from the 15th day of Feb. A. D. 1931, until the 15th day of Feb. A. D.  
1933, provided that if in the meantime a free Bridge is constructed this contract will immediat-  
ely terminate and become of null and void.

Know all men by these presents; that, whereas, C. N. McCown has  
this day been duly employed by the Commissioners' court of said  
County to operate a Ferry for the space of two years, if necessary, next ensuing after the date  
hereof at Pendleton, on the Sabine River, in said County, and to charge the rates of Ferriage  
established by said court for crossing therewith; during night time only.

Now, therefore, we the said C. N. McCown, as Principal, and A. L. McGown, and T. S. Waller  
as sureties, acknowledge ourselves bound to pay to the County Judge of said County, of Sabine,  
the sum of \$1000.00 conditional that the said above will at all times keep the banks on each side  
of the Ferry in good repair and so graded and leveled that the rise shall not exceed one foot  
in every seven feet from the water's edge to the top of the bank, and that said Ferry shall be  
well attended all times, and that he will comply with all the requirements of the law relating  
to or governing ferries.
