The Commissioners Court of Sabine County, Texas, met in Special Session, December 31st, 1932, with the following members, to-wit: R.H. Dent, County Judge, E.J. Mc own, Commr. Prec. No. 1, W.R. Low, Commr. Prec. No. 3, N.E. McDaniel, Commr. Prec. No. 2, and Mrs. Berta Harper, Co. Clerk, and transacted the following business, to-wit:

That the Machinery of Hemphill Gun Company which appears on the Tax Rolls at \$3000.00 be reduced to \$2500.00, for the reason that this was the figure agreed upon by the Board of Equalization which is also the final value as shown by the minutes of the Board of Equalization and the fact that it shows on the Roll at a different figure is an error. The Tax Collector is therefore authorized to make this correction on the rolls and to charge off \$500.00 from the \$3000.00 given on this machinery as an error in assessment.

It is also ordered by the court that Road and Bridge Funding Warrants No's 8 to 25 inclusive, of \$1000.00 each dated Nov. 15, 1930, be cancelled and destroyed.

Also that General Funding Warrant No. 1, in the amount of \$93.45 dated April 10, 1932, be cancelled and destroyed & Warrant No. 2, of the same issue in the sum of \$1000.00 be issued in lieu thereof.

It is further ordered by the court that the term of W.H. Waller as Ferryman of Pendleton Ferry be extended twelve months from date conditioned on his making bond and such bond being approved by the Commissioners Court.

The final report of the County Treasurer, D.A. Sibley, is approved.

The court acknowledged receipt of one leading Wheel grader of J.D. Adams & Co., at the price of \$1476.16, fourteen hundred and seventy-six dollars and sixteen cents, which grader has been in use by the County for over one year and no payment therefor has been made. The court would therefore say the county is justly indebted to said J.D. Adams & Co. for such machinery, but no payment is ordered made at this time.

On this day were filed bonds of County officers, to-wit: Perry Henderson Mc own, Comm. Precinct No. 3, R.W. Chapman, Comm. No. 4, A.G. Pratt, Tax Assessor; B.A. Minton, Constable of Prec. No. 8, L.L. King, County Attorney; C.C. Minton, Justice of Peace Prec. No. 8; Ernest Smith, Comm. Prec. No. 2; A.J. Neal, Public Weigher Prec. No. 1; James L. Payne, County

Treasurer; W.M. Honeycutt, District Clerk; Said bonds for the above named officers were duly approved by the court.

It is also ordered by the court that all county bills and salaries are approved up to and including Dec. 31st, 1932.

No further business, to be considered, court is adjourned.
