Filler, the difference in taxes of Road District # 4 and # 5, for the year 1952, and charge the amount to error in Assessment, for the reason that here B. Filler lives in Road District # 4, and assessed for Road Sitrict No. 5.

That the Tex Collector, Ross Kenner, We and he is hereby authorized to refund to D. B. Lasley the difference in taxes of Road District No. 4 and No. 5, for the years 1930 and 1937, and charge the amount to error in assessment, Mr. Easley also living in District # 4 and assessed for District No. 5.

of D. D. Hasley, for the year 1932, the difference between Road District # 4, taxes and Road District No. 5, taxes, for the reason that Mr. Easley is assessed for the year 1932 for taxes in District No. 5, and lives in District No. 4, the amount to be deducted to be charged to error in assessment.

On motion duly had and carried, it is ordered by the court that the ponds of D. E. Cooper as Constable of Frecinct No. 2, and E. F. McDonald as Justice of the Feace Frecinct To. . De and the same are hereby, in all strings, approved.



On motion duly had and carried, it is ordered by the court as follows:

That Script Nos. 194, 154, 35, and 104, in the amounts of \$3.00, \$3.00, \$3.00, \$5.00, \$6.00, and script respectively, issued to a.L. McYown, for service on County School board be cancelled, and script and light thereof, be issued out of the Gen. Co. Fund, in the Amount of \$15.00, for the same our pose.

That crip No. 787, in the amount of \$106.67, issued to C.M. Bennett, be cancelled and script in lieu thereof, be issued out of the same fund, for the same purpose but in the following amounts: One piece for \$4.20, one for \$12.47, and nine pieces of \$10.00 each.

That script No. 537, issued to Ben camilton, out of the R. & B. Fund, for \$12.00, be cancelled and scrip in lieu thereof, be issued in the amounts of \$7.35 and \$4.65, out of the same fund and for the same purpose.

That Scrip No. 556, issued to W. B. Palmer, out of the R. & B. Fund, in the amount of \$15.00, be cancelled and scrip in lieu thereof, in the amounts of \$6.45, and \$8.65, out of the same fund and for the same purpose.
