

The commissioners' court in and for Sabine County, Texas met in Special Session, March 3, 1933, with the following members presents, to-wit: Edward Harper, County Judge, P.H. McGown, Commr. Prect. No. 2, H.E. White, Commr. Prect. No. 1, E. C. Smith, Commr. Prect. No. 3, R. W. Chapman, Commr. Prect. 4, and Geo. W. Russell, Sheriff, and Zeda Davidson, County Clerk, and at which time the following business was transacted.

On motion by P.H. McGown, second by E. C. Smith, vote unanimous, it is ordered by the Commissioners' court of Sabine County, Texas, in special session this the 4th day of March A. D. 1933, that the Tax Collector of Sabine County, correct his rolls on the rendition of the party of the United Gas Public Service Service Company, and that the School tax money paid by said company be divided equally between Pineland Independent District No. 3, and Common School District No. 31; that each of said districts be given fifty (50%) per cent of the

school Tax paid by said company. It is further ordered that the school tax paid by the Agnolia Pipe Line Company, covering Oil Station, be all paid to Common School District No. 31, and that none of said school Tax be paid to Independent School District No. 3.

It is ordered by the court that scrip No. 747, issued to Mrs. W.L. Amey, in the sum of \$8.50, be canceled and scrip in lieu thereof be issued in the amounts of \$3.45 and \$5.05 for the same purpose.

On motion by P.H. McGown, second by H.E. White, that the following petition be, and the same is hereby granted.

 County of Sabine ) To the Honorable Commissioners' court of Sabd County; The undersigned free holders in precinct No. 3 in said County, represent that for the convenience of themselves, and of the public generally they desire a new public road to be opened, beginning at the Henry Horn place and terminating at Rural route 2.

Wherefore they pray for the appointment of a jury of View to lay out and mark said road, and that the same be opened and established as a public road. This 4th day of February, A.D. 1933.
