On motion duly had and carried, it is ordered by the court that scrip, No. 1111, payable to Mrs. J.O. Mc, onald, in the sum of \$3.00, for holding Special Election, be cancelled, and scrip in lieu thereof, be issued in the sum of \$1.60, and \$1.40, out of the same fund and for the same purpose.

On motion duly had and carried, it is ordered by the court that Scrip # 970; issued to J.H. Conn, for Grader Work, in the sum of \$22.00 out of the R. & B. wind, be cancelled, and scrip in lieu thereof, be issued in the amounts of \$18.15 and \$3.85, out of the same fund and for the same purpose.

On motion duly had and carried it is ordered by the court that scrip # 543 issued to E.L. alford, out of the "& B. Fund, for driving Tractor, we cancelled, and scrip in lieu thereof, be issued out of the same fund for the same purpose and in the sums of 68.70 and 15.30.

On motion duly had and carried it is ordered by the court that scrip # 1036, issued to W.H. Pratt, for criminal fees in the sum of \$21.00 be cancelled and scrip in lieu thereof, be issued out of the same fund and for the same purpose but in the sums of \$11.52, and \$9.48,

On motion by B.H. Mc. own, seconded by E.C. Smith vote unanimous, it is ordered by the Court that the Quarterly report of J.L. Payne, be, and the same is hereby approved.

On motion by H.L. White, seconded by P.H. Mcgown, vote unanimous, it is ordered by the court that the Financial Statement for the first and second quarters of the year, made by Zeda Davidson, County Clerk, reporting the condition of the County, as per Finance Ledger, be and the same is hereby in all things approved.

Whereas, at a meeting of the Commissione's court in August, 1933, the court set the tax rate of Common School District No. 30, at the rate of 1.00 on the 100.00 valuation, and

Whereas, it has come to the knowledge of the court that, through error, said rate was placed on the minutes of the court at the rate of 75¢ on the 100.00 valuation, instead of \$1.00;

And, whereas, on motion by H.E. white, second by P.H. Mc own, vote unanimous, it is ordered by the court that the Tax Collector, be, and he is hereby authorized, to collect taxes for said school District at the rate of \$1.00 on the \$100.00 valuation, instead of 75% on the \$100.00 valuation for the year 1933.

Whereas, it has come to the knowledge of the Commissioners court that the maxes of Fagnolia Pipe Line Company, on pipe line, for Road District No. 10, was placed on the rolls at the rate of \$1.00 which is an error, and should be figured at the rate of \$5.50, on the \$100.00 valuation

Whereas, on motion, by P.H. Mc own, second by E. C. Smith, vote unanimous, it is ordered by the court that the Tax Collector, be and he is hereby authorized, to collect taxes at the rate of 50¢ on the \$100.00 valuation in road district No. 10, for the taxes on Magnolia Pipe Line Company.

Accounts were allowed as per account ledger.

There being no further business, court is adjourned.
