TO THE HONORABLE COMMISSIONER'S COURT OF SABINE COUNTY, TEXAS:

We, the undersigned residents of Sabine County and property tax-paying voters of said County, hereby respectfully petition your Honorable court to establish a public road as follows:

In Sabine County, beginning on Highway No. 87, at the five mile board south of Hemphill on the yellowpine road and then running northeast with the present settlement road as near as possible, passing the residence of Ed Knighton, on the J. W. Minton farm, on the John Haley survey and running on to the residence of Hamp Ener, a distance of about 1 1/2 miles.
