

The Commissioners' court in and for Sabine County, Texas, met in Regular Session January 22nd, 1934, with the following members Present, to-wit, Edward Harper, County Judge, H. E. White Commr. Prec. No. 1, E. G. Smith, Commr. Prec. No. 2, P. H. McGown, Commr. Prec. No. 3, R. W. Chapman, Commr. Prec. No. 4, and Zeda Davidson, County Clerk, and transacted business as follows:

On motion by E. G. Smith, second by R. W. Chapman, that the following scrip be cancelled and scrip in lieu thereof be issued as follows:

Scrip No. 1193 in the amount of \$3.00, issued to J. R. Smith, out of the General County Fund, be cancelled and scrip in lieu thereof be issued out of the same fund for the same purpose but in amounts of \$1.56 and \$1.44.

That scrip No. 659, issued to W. R. Low, in the amount of \$16.75, out of the R. & B. fund, be cancelled and scrip in lieu thereof be issued out of the same fund, for the same purposes and in the amounts of \$8.80 and \$7.95.

That Scrip No. 1104, issued to R. M. Pinkston, in the amount of \$3.00, out of the General County Fund, be cancelled and scrip in lieu thereof, be issued out of the same fund, for the same purposes in amounts of \$1.62 and \$1.38.

That Scrip No. 171, issued to Gervis Buckley, in the amount of \$26.00, out of the R. & B. Fund, be cancelled and scrip in lieu thereof be issued out of the same fund, for the same purpose and in amounts as \$11.20 and \$14.80.

That scrip No. 600 issued to John Zager, in the amount of \$65.00 out of the R. & B. fund, be cancelled, and scrip in lieu thereof, be issued out the same fund for the same purposes and in the sum of \$10.56 and \$54.44.

That scrip No. 718, issued to C. M. Bennett, out of the General County Fund, in the amount of \$10.00 be cancelled and scrip in lieu thereof, be issued out the same fund, for the same purposes in amount of \$4.48, and \$5.52.

That Scrip No. 1182, issued to W. N. Garriott, in the amount of \$9.60, out of the General County Current Expense fund, be cancelled and scrip in lieu thereof, be issued out of the same fund, for the same purposes in amount of \$5.60 and \$4.00.

That scrip No. 1119, issued to D. E. Willis, out of the General County Fund, in the amount of \$5.00, be cancelled and scrip in lieu thereof, be issued out of the same fund, for the same purposes and in amount of \$3.68 and \$1.32.

That scrip No. 977, issued to Walter Phelps, in the amount of \$8.50, out of the R. & B. Fund, be cancelled and scrip in lieu thereof, be issued out of the same fund, for the same purposes and in amount of \$4.80 and \$3.70.

That scrip No. --- issued to P. H. McGown, in the amount of \$59.49, be cancelled and scrip in lieu thereof, be issued out of the same fund, for the same purposes and in amount of \$25.44 and \$34.05.

Accounts were allowed and shown by account ledger.
