

The Commissioners' court in and for Sabine County, Texas, met in Regular Session, March 26th, 1934, with the following members present to-wit: Edward Harper, County Judge, H.E. White, Commr. Prec. No. 1, E.C. Smith, Commr. Prec. No. 2, P.H. McGowan, Commr. Prec. No. 3, R.W. Chapman, Commr. Prec. No. 4, and Zeda Davidson, County Clerk, and transacted business as follows:

On motion by R.W. Chapman, seconded by E.C. Smith, it is ordered by the court that Alvin Whittlesey be and he is hereby appointed Janitor for the Court House and Jail, at the salary of \$30.00 per month.

On motion by H.E. White, seconded by E.C. Smith, it is ordered by the court that the Tax Collector be, and he is hereby authorized to change the rolls on property rendered by Mrs. A.E. Cunningham, making her homestead on the 78 acres of the W. Coley, survey instead of the 2 acres of the Joseph Walker.

On motion by E.H. White, and seconded by R.W. Chapman, it is ordered by the court that a fund to be known as Road and Bridge Fund "A" be created, and that scrip which has been improperly issued against the permanent improvement fund be registered according to number against said

Road and Bridge Fund "A"; and it is further ordered that after the legal scrip registered, against the permanent improvement fund has been paid, that the surplus be placed prorata with the General County Fund "A" to the credit of the aforesaid road and bridge fund "A" and it is further ordered and decreed that a prorata part of the delinquent taxes for the year 1932 when collected be placed in the above fund.

On motion of H.E. White, and second by R.W. Chapman, it is ordered by the court that a Fund be known as General County "A" Fund, be created, and that scrip that has been improperly issued against the Permanent Improvement Fund be registered according to number against said General County "A" Fund; and it is further ordered that after the legal scrip registered against the permanent improvement fund has been paid, that the surplus be placed to the credit of the aforesaid General County "A" Fund; and it is further ordered and decreed that a prorata part of the delinquent taxes for the year of 1932 when collected be also placed in the above fund.

On motion by E.C. Smith, seconded by H.E. White, with a vote unanimous, in favor of said motion, it is ordered by the court that there be and there is hereby created a fund to be designated as "General County "B" Fund," to be used as Court House officers salaries. It is further ordered that scrip already issued, on the General County Current Expense and Road & Bridge Current Expense for such salaries for the year 1934, be cancelled and scrip in lieu thereof be issued on the above mentioned General County "B" fund, and the treasurer is hereby directed and ordered to cancel such scrip and register same against said General County B. Fund.

It is ordered by the court that scrip already issued on the General County Current Expense Fund, for expenses incurred during the year 1934, be cancelled and scrip in lieu thereof, be issued and registered by the Treasurer on 1934 current Expenses, beginning at # 1.

Accounts were allowed as shown by account ledger.

No further business coming before the court it is adjourned.
