The Commissioners' court, Sabine County, Texas, met in Regular term, with the following members present, to-wit: Edw. Harper, County Judge, H. H. White, Commr. Precinct No. 1, E. C. Smith, Commr. Precinct No. 2, and R. W. Chapman, Commr. Precinct No. 4, Geo. W. Russell, Sheriff, and Zeda Davidson, County Clerk, Sabine County, Texas, and transacted business as follows:

Accounts were allowed and approved, as is shown by accounts allowed.

On motion made by H. E. White, Seconded by E. C. Smith, with a vote unanimous in favor of said motion, it is ordered by the court that \$850.00 of the Permanent School Bonds be invested in two Five Hundred Dollar bonds of Road District # 3, of Sabine County, at 5 1/2 % interest.

On motion made by R. W. Chapman, seconded by H. E. White, with a vote unanimous in favor of said motion, it is ordered by the court that the petition of E. B. Padgett, to clear the road leading to S. J. Davidson's of obstructions, be and the same is hereby refused.

On motion by E. C. Smith, seconded by R. W. Chapman, with a vote unanimous of same, it is ordered by the court that the quarterly report of J. L. Payne be and the same is hereby approved.

On motion by H. E. White, seconded by R. W. Chapman, with a vote unanimous in favor of said motion, it is ordered by the court that the following petition be and the same is hereby in all things granted, and the election for such be and is hereby ordered held Nov. 27, 1934.

Petition as follows:

Hemphill, Texas,
September 8, 1934.

To the Hon. Commissioners court, of Sabine County, Texas:

We, the hereinafter named freeholders, resident citizens in the corporate limits of the abolished corporation of the town of Hemphill, petition your honorable Court, and request that an order for an election be passed by your body to be held in said corporate limits of the abolished corporation of the town of Hemphill, and that some day named in the order for the purpose of enabling the freeholder of said subdivision to determine whether hogs, sheep or goats shall be permitted to run at large within the following boundaries to-wit:

Beginning at a point on the E. bank of Cooper branch at the S. W. cor. of a 36.8 acre survey owned by Mrs. L. M. Knox. Thence in a northerly direction with the meanders of said Cooper branch to where said branch crosses the street leading from Hemphill to Eastmayfield, at the N. W. cor., of the P. M. Coussons tract. Thence E. with the S. margin of right of way of said street from Hemphill, to Eastmayfield to where same interests the N. B. line of the town of Hemphill, to the most southerly corner of the A. D. Hamilton tract in said N. B. line of said town of Hemphill. Thence N. 60 W. along with Hamilton's line 140 vrs. to corner in E. margin of Hemphill-Bronson highway. Thence N. 53 E. 25 vrs. to cor. Thence N. 6 1/2 W. along Hamilton's W. B. line 240 vrs. to corner in the S. B. line of the E. W. Clark 11-1/5 acres. Thence in an Easterly direction along said E. W. Clark's S. B. line to his S. E. cor. Thence northerly with the E. B. line of said E. W. Clark tract to his N. E. cor., same being the N. W. cor. of the A. D. Hamilton land. Thence N. 71 E. 407 vrs. with the N. B. line of said Hamilton tract. Thence N. 134 1/2 vrs. to cor., same being the S. E. cor. of the Hamilton & Minton 4 acre tract. Thence S. 74 1/2 W. 229 vrs. to S. W. cor., of said Hamilton & Minton 4 acre tract. Thence N. 155 vrs. to the N. W. cor. of said 4 acre tract. Thence in a N. E. direction with the N. B. line of said 4 acre tract to the point where said line intersects the S. B. line of the right of way of the L. H. & G. Ry. Co. Thence N. to the S. W. cor., of a 2 acre block known as the G. W. Speights 2 acre tract. Thence N. 74 E. with the S. E. corner at 1222 vrs. stk. cor. in W. B. line of the G. W. Alford 7 acre tract. Thence N. with Alford's E. B. line to his N. W. corner. Thence N. 76 E. 1064 vrs. the S. W. corner of the J. O. Toole 52-3/4 acre survey continue same course along Toole's S. B. line to a point in said line where the East edge of the Hemphill & Milam highway to its intersection of said road with the highway leading from Hemphill to Sabinetown Thence South with a subdivision out of said Jos. Walker survey owned by Mrs. L. M. Knox, to the S. B. line of said Joseph Walker survey to a point where said line intersects the N. B. line of the John Haley survey. Thence in a N. E. direction with the N. B. line of said Haley survey to its N. W. corner, Thence continuing said course along the S. B. line of said 38-5/8 acre tract owned by Mrs. L. M. Knox to the place of beginning.
