

PUBLIC NOTICE:

Be it remembered that on November 6, 1934, there was held in the different election precincts of Sabine County, Texas, an election to determine whether the sale of beer containing not more than three (3.2%) and two-tenths per centum of alcohol by weight shall be permitted or prohibited in Sabine County; and on November 12, 1934, the Commissioner's Court with the following members present; Edward Harper, County Judge; Zeda Davidson, County Clerk; H. E. White, Commissioner Precinct No. 1; E. C. Smith, Commissioner precinct No. 2; P.H. McTown, Commissioner Precinct No. 3; R. W. Chapman, Commissioner precinct No. 4, met to canvass the votes of said election. Court having been duly opened by proclamation of the sheriff, the votes were counted, and it was found that there were cast 1158 votes, of which 477 were cast for the sale of beer containing not more than three (3.2%) and two-tenths per centum of alcohol by weight, and 661 votes were cast against the sale of beer containing not more than three (3.2%) and two tenths per centum of alcohol by weight, showing majority against said sale of beer of 184 votes.

Now, therefore, take notice that after December 21, 1934, being thirty (30) days after the date of this order, it shall be unlawful for any person, partnership, or corporation to manufacture, sell or barter beer containing not more than three (3.2%) and two-tenths per centum of alcohol by weight within said Sabine County, Texas, and the same is absolutely and totally prohibited. It is further proclaimed and directed that this order shall be published in the Sabine County Reporter, a Newspaper, published at Hemphill, Sabine County, Texas, for four consecutive times as required by law.

Russell, Sheriff, and Zeda Davidson, Clerk, and transacted business, as follows, to wit: Accounts, were allowed and approved as is shown by Minutes of Accounts Allowed:

On motion made by H. E. White, seconded by E. C. Smith, it is ordered by the court that Scrip No. 1020, Issued to W. H. Crowell, for Holding General Election, in the amount of \$5.10, on the General Co. Cur. Ex. fund, be cancelled and scrip in lieu thereof, be issued on the same fund, for the same purpose but in the sum of \$1.37, and \$3.73.

On motion made by H. E. White, and seconded by R. W. Chapman, it was ordered by the court that the 75 acre tract of land, abstract No. 11, on the M. Cummings survey, which has been erroneously placed on the unrendered Tax roll, be placed on the rendered roll, and the tax collector be authorized to accept taxes on same at the value of \$5.00 per acre for the years of 1932 and 1933 and 1934.

There being no further business, court is adjourned.
