The Commissioners' court met in Regular Session July 22nd, 1935, with all members present as follows: Edw. Harper, County Judge, T. R. Smith, Commr. Prec. No. 1, E. C. Smith, Commr. Prec. No. 2, P. H. McGown, Commr. Prec. No. 3, R. W. Chapman, Commr. Prec. No. 4, Geo. W. Russell sheriff, and Zeda Davidson, County Clerk, and transacted business as follows:

Accounts were allowed and approved as is shown by Minutes of Accounts Allowed:

On Motion made by P.H. McGown, seconded by E. C. Smith, with a vote unanimous, it is ordered by the court that the Quarterly report of Roy Payne, be and is hereby in all things approved.

On motion duly made and carried, it is ordered by the court that scrip No. 1868 issued to H.E. White, in the sum of \$93.34, be on the Gen. Co. "B" fund, be cancelled and scrip in lieu thereof be issued as follows: \$70.00 out of the Gen. Co. "B" fund and \$23.34 out of the Road & Bridge Current Expense Fund.

On motion by T. R. Smith, seconded by P.H. McGown, with a vote unanimous it is ordered by the court that the hereinafter described petition be granted, and that the road be granted as a second class road. Petition as follows:

The State of Texas. To the Commissioners Court of Sabine County, Texas.  
County of Sabine

The undersigned freeholders of Precinct No. 2, in said County, represent that for the convenience of themselves and the public generally they desire a new public road to be opened, beginning at Highway # 5 about one mile and three quarters (13/4) south of Yellowpine, Texas; and more particularly at O.E. Solly's Residence, and terminating eastwardly from highway # 5 to the residence of R.H. Hyden's place.

Wherefore they pray for the appointment of a jury of view to lay out and mark said road, and that the same be opened and established as a public road. This 29 day of June, A.D. 1935/
